Small Black re-released its self-titled debut EP, issuing it anew with a host of unreleased recordings from that time period. It's now a double LP.

The songs from that era are lovingly low-stakes, the reflection of creating the album in Kolenik's uncle's house in Long Island. The band has now long been a solid foursome (bassist Juan Pieczanski on bass and drummer Jeff Curtin round out the group), but their halcyon days involved Kolenik and Heyner exploring fuzzed-out electronica on old-school synthesizers.

"That was just a magical time," said Kolenik. "We were using really simple Casio synths, and I don't know — they just created this really raw emotion."

The first song written during those early sessions as Small Black was "Despicable Dogs," perhaps the defining document of the chill-wave era. A crackly, digitized effort, "Despicable Dogs" 'is nonetheless laden with so much real human emotion (and unstoppable hooks), as Kolenik sings opaquely about connection, loss and finding one's place in the world. Though Small Black is

running through the full "Limits of Desire" album on its current slate of live shows, "Despicable Dogs" 'still finds a way into the nightly set list.

"That song is about a lot of things I was going through, in terms of losing a parent and being young and in relationships, and other difficulties," said Kolenik. "And there is some sort of confluence of those sentiments that ends up in the hook. It just seems to work."

Despite being spread out over the country — Kolenik moved to Los Angeles in 2022, and Heyner now lives in Florida, while the other two members are in New York — Small Black has a bevy of recorded material which it hopes to release soon on a new album, possibly next year.

Having survived the whims of industry changes, the band is now looking forward to the future, some 15 years after forming.

"I know every artist says this, but I think the new songs are some of the best we've ever recorded," said Kolenik. "It's feeling like a pretty coherent album. I think we're all excited to see what comes next for the band."
