ORDINANCE SUMMARY
AN ORDINANCE OF THE CITY OF DALY CITY ADDING CHAPTER 17.58 COMMERCIAL MIXED USE (C-MU) DISTRICT TO THE DALY CITY MUNICIPAL CODE AND AMENDING THE ZONING MAP - REZONING VARIOUS PARCELS OF APPROXIMATELY 65 ACRES LOCATED ON MISSION STREET AND GENEVA AVENUE FROM C-1 LIGHT COMMERCIAL TO COMMERCIAL-MIXED USE (C-MU).

1. SUMMARY
This Ordinance shall add Chapter 17.58 to the Daly City Municipal Code establishing a new C-MU Commercial Mixed Use Zoning District for the Mission Street and Geneva Avenue corridors, rezoning parcels within these corridors from C-1 Light Commercial to Commercial-Mixed Use (C-MU) and establishing Objective Design Standards for all new buildings in these corridors.
The City Council has reviewed the proposal and the requirements of the California Environmental Quality Act (CEQA) and has determined, that an Addendum to the General Plan's Certified EIR is the appropriate environmental review for proposed changes to the Zoning Ordinance, Zoning Map and General Plan.
2. CERTIFICATION AND POSTING
A certified copy of the full text of this Ordinance is located in the office of the City Clerk, City Hall 333 90th Street, Daly City, California. This ordinance was introduced by the Daly City City Council on November 27, 2023, and scheduled for second reading and adoption on December 11, 2023.
