This fee shall be paid to Public Works in accordance with Public Works Code, Section 793.2(b). A City Agency or Department may also charge additional fees for permits required, or services performed, to implement the People Place Proposal submitted by a Steward, but shall be one-half the fee that the Agency or Department is authorized to charge. In accordance with Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments to the City prior to the time the hearing begins. These comments will be made as part of the official public record in this matter, and shall be brought to the attention of the members of the Committee.
