7 MOVED, That the Board of Supervisors of the City and County of San Francisco does
8 hereby appoint the hereinafter designated persons to serve as members of the San Francisco
9 Health Authority, pursuant to the provisions in the California Welfare and Institutions Code,
10 Section 14087.36, and the San Francisco Administrative Code, Sections 69.1 et seq., for the
11 terms specified:

12 Jian Qing Zhang, seat 2, succeeding themselves, term expired, must be employed in the
13 senior management of a hospital not operated by the county or the University of California
14 and who is a nominee of the San Francisco Section of Westbay Hospital Conference or any
15 successor organization, or if no successor organization, a person who shall be nominated by
16 the Hospital Council of Northern and Central California, for the unexpired portion of a three-
17 year term ending January 15, 2023;

18 Roland Pickens, seat 3, succeeding themselves, term expired, must be employed in the
19 senior management of San Francisco General Hospital, for the unexpired portion of a three-
20 year term ending January 15, 2024;

21 Emily Webb, seat 4, succeeding themselves, term expired, must be employed in the
22 senior management of St. Luke's Hospital (San Francisco), for the unexpired portion of a
23 three-year term ending January 15, 2024;

1 Joseph Woo, seat 7, succeeding Lawrence Cheung, term expired, must be a physician,
2 nominated by the San Francisco Medical Society, or any successor organization, for the
3 unexpired portion of a three-year term ending January 15, 2024;

4 Steven Fugaro, seat 8, succeeding themselves, term expired, must be a physician,
5 nominated by the San Francisco Medical Society, or any successor organization, for the
6 unexpired portion of a three-year term ending January 15, 2024;

7 Steve Fields, seat 12, succeeding themselves, term expired, must be knowledgeable in
8 matters relating to either traditional safety net providers, health care organizations, the Medi-
9 Cal program, or the activities of the Health Authority, and nominated by the program
10 committee of the Health Authority, for the unexpired portion of a three-year term ending
11 January 14, 2024;

12 Eddie Chan, seat 6, succeeding themselves, term expired, must be employed in the
13 senior management of either private nonprofit community clinics or a community clinic
14 consortium, nominated by the San Francisco Community Clinic Consortium, or any successor
15 organization, for the unexpired portion of a three-year term ending January 15, 2025.
