WHEREAS, A copy of the Management Contract is on file with the Clerk of the Board of Supervisors in File No. 181035; and

Whereas, On November 29, 2022, the Board of Supervisors approved the Discover Polk CBD's annual reports for fiscal year 2020-2021 in Resolution No. 504-22; and

WHEREAS, The Discover Polk CBD has submitted for the Board's receipt and approval the Discover Polk annual report for fiscal year 2021-2022 as required by Section 36650 of the Act and Section 3.4 of the Management Contract; and

WHEREAS, The Annual Report is on file with the Clerk of the Board of Supervisors in File No. 231279, and is incorporated herein by reference as though fully set forth; and

WHEREAS, Supporting documents, including, but not limited to, a transmittal letter and memorandum report from the City's Office of Economic and Workforce Development, dated July 20, 2022, and documentation from the Discover Polk CBD for the Annual Report is on file with the Clerk of the Board of Supervisors in File No. 231279; now, therefore, be it
