1 For the purpose of this analysis, a General Fund reserve is a set aside (undesignated) for unanticipated expenditures (contingencies) in General Fund departments. 2 Orange County uses its General Fund reserve for a broad range of expenditures, not just in response to unexpected larger-than-budgeted expenditures. 3 The City of Los Angeles is considering raising the General Fund reserve allocation percentage from about 2% to 5%. This fund is divided into two parts: one for contigencies,								
the other for emergencies.								
4 City of San Diego staff stated that over time they hope to increase the reserve allocation to 5%. 5 Information on Alameda County's General Fund reserve carry forward could not be obtained for this report.								
6 In FY 03-04, the County of Santa Clara reserved \$69M of general fund monies. It is not clear what percentage of this amount, if any, was set aside as a General Fund reserve. 7 San Jose has a minimum allocation requirement of 3% (to be met by a combination of carry forward and appropriation).								
8 The City of Long Beach did not have a General Fund reserve until FY 04-05. In FY 03-04, it had an Emergency reserve of \$36 million, equivalent to 10% of the total General Fund budget.
