Re: IHSS Public Authority Governing Body Appointment Process

SUMMARY OF REQUESTED ACTION

Supervisor Alioto-Pier requested that the Office of the Legislative Analyst research how all other counties in California appoint members to the governing body of their IHSS public authority.

BACKGROUND

The In-Home Supportive Services (IHSS) program was created by each county to provide services to qualified aged and disabled persons, allowing them remain in their homes while receiving personal care services. In an attempt to improve the IHSS program for consumers and providers, the idea of a public authority was developed to work in conjunction with the IHSS program. In 1999, California passed AB 1682, requiring that on or before January 1, 2003, each county shall act as, or establish an employer of record for the IHSS program. According to Section 12301.6 of the Welfare and Institution Code, a county board of supervisors has the authority to do either of the following:

- 1. Contract with a nonprofit consortium to provide for the delivery of IHSS.
- 2. Establish, by ordinance, a public authority to provide for the delivery of IHSS.

Each public authority must have a designated governing body to conduct program oversight, including making appointments to the advisory committee and providing recommendations on service enhancements and IHSS operations.

FINDINGS

In San Francisco, the IHSS public authority has an independent governing body. The members include: one Commissioner recommended from each of three San Francisco Departments: the Department of Aging and Adult Services (DAAS), the Department of Human Services (DHS), and the Department of Public Health (DPH); one member recommended by the Mayor's Disability Council; six current or past users of personal assistance services; and one home care worker representative. According to the San Francisco Administrative Code, "the governing body of the Authority shall be composed of 11 members appointed by the Board of Supervisors. The Board of Supervisors shall solicit recommendations for appointment of qualified members through a fair and open process, including

reasonable written notice to, and affording reasonable response time from, members of the general public and interested persons and organizations." The Board of Supervisors made the initial appointments to the public authority governing body upon its establishment in 1995. However, the IHSS public authority has made all subsequent appointments.

Upon further research among the 58 California counties regarding IHSS public authority and governing board appointment authority, the OLA found the following:

- There are 9 counties with independent governing bodies¹ (Amador, Los Angeles, Marin, Monterey, Nevada, Plumas, San Francisco, San Luis Obispo, and Sierra). Among all of these counties, the board of supervisors is designated to appoint members to the public authority governing body.
- 41 counties have ordinances that designate the board of supervisors as the governing body of the public authority.
- 3 counties (Alpine, Trinity, Tulomne) do not have a public authority.

Attachment 1 lists the appointment authority of the IHSS governing body by county.

METHODOLOGY

The OLA surveyed the 58 California counties regarding their IHSS public authority and governing body.² The OLA used the Internet to search through county public authority websites and made phone calls to public authority administrators to obtain information. Specifically, the OLA asked the following questions:

- 1. Who is the governing body of the IHSS public authority?
- 2. Who has the authority to appoint members to the public authority?
- 3. How many members serve on the governing body?
- 4. What year was the public authority established?

Additionally, the OLA contacted the California Association of Public Authorities, the California Department of Aging, the California State Association of Counties, and the California State Assembly.

CONCLUSION

In California, the majority of county IHSS public authority governing bodies is the board of supervisors. They have no appointing authority to the governing body as their appointments are established through county ordinances. There are a small number of public authorities with independent governing bodies and the board of supervisors holds the appointing authority within these counties. Of the counties that were surveyed, in no instances did I find that a county public authority made appointments to the governing body.

¹ An independent governing body is an entity that is separate from the county.
