If the legislation passes, a \$385.00 filing fee for a Limited Live Performance application and a \$129.00 filing fee for an Amendment to Permit application will be payable to the Police Department or Entertainment Commission. A \$139.00 fee for a Limited Live Performance license renewal will be payable to the Tax Collecter after issuance by the Police Department or Entertainment Commission.

When filing an appeal of actions taken on the granting, denial, amendment, suspension or revocation of a Limited Live Performance permit, the appellant shall be subject to existing filing fees due to the Board of Appeals per Section 8 of the San Francisco Business and Tax Regulations Code.
