NOTICE IS HEREBY GIVEN THAT the Board of Supervisors of the City and County of San Francisco, will schedule a public hearing, at a Committee of the Whole to consider the Final Mitigated Negative Declaration (FMND) under the California Environmental Quality Act (CEQA), the CEQA Guidelines, and San Francisco Administrative Code, Chapter 31, for the Hall of Justice project located at 850 Bryant Street, Board of Supervisors File No. 150702. Normally a negative declaration would be appealable after the first City decision-makers approve a project and adopt the negative declaration as part of that approval. Here, the Board of Supervisors is the first City decision-maker to consider approval of the project and adoption of the FMND. Thus there would be no appeal of the FMND, since the Board is an elected decision-making body and would consider adopting the FMND.

Therefore, the Board intends to hold a public hearing on the adequacy of the FMND before it considers approval of the project and adoption of the FMND as a required part of any approval action. At that hearing, the Board may affirm or reverse the Planning Commission's approval of the FMND. Following the hearing on the FMND, the Board will consider the Project and adoption of the FMND on July 21, 2015. (See Board of Supervisors File No. 150701.) If the Board affirms the FMND, approves the Project and adopts the FMND, the City would file a Notice of Determination in compliance with CEQA and Administrative Code Section 31.17.

In accordance with Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments to the City prior to the time the hearing begins. These comments will be made part of the official public record in this matter, and shall be brought to the attention of the members of the Board.
