**Policy Analysis Report**

**Summary of Requested Action**

Your office requested that the Budget and Legislative Analyst conduct a study on municipal fines. Specifically, you requested that we establish a comprehensive list of all the municipal fines that the City has the power to levy on residents and visitors including: (1) what fines exist; (2) the frequency of the fines; (3) the amount of monies that each fine elicits for the City on an annual basis; and, (4) the options for repayment for each fine as well as the consequences if the fine is not paid. You also requested that we calculate the revenues brought in from municipal fines as a percentage of the citywide budget.

**Executive Summary**

- As seen in the comprehensive list of municipal fines attached to this report, we have identified approximately 430 violations of City ordinance or contracts over the last three fiscal years that are subject to a fine. Further, we found that 1,866,614 municipal citations were issued in Fiscal Year (FY) 2014-15 and \$88,639,237<sup>1</sup> in revenue was collected in FY 2014-15 from municipal fines. This represents about 1.03 percent of the FY 2014-15 budget as proposed by the Mayor in June 2014.<sup>2</sup>
- As seen in Exhibit 1 below, the San Francisco Municipal Transportation Agency (MTA) issued a majority of citywide citations over the last three years. MTA citations have primarily been issued for parking on a street during street sweeping days and hours, failure to pay a parking meter, parking in excess of the hours permitted in a residential or carpool zone, and improper parking on grades.

- As seen in Exhibit 2 below, the MTA also collected the highest amount of revenue from the issuance of municipal fines. In total, MTA collected \$82,438,866 in FY 2014-15, primarily from the same violations with the highest number of citations issued (parking on a street during street sweeping days and hours, failure to pay a parking meter, parking in excess of the hours permitted in a residential or carpool zone, and improper parking on grades).

- California Government Code Section 53069.4 and Chapter 100 of the City's Administrative Code establish standard procedures for the imposition, enforcement, collection, and administrative review of "administrative fines." These code sections govern many of the municipal fines cited in San Francisco. However, very few citations undergo the administrative appeals process staffed by the Controller's Office—only 12 total violations underwent the appeals process in FY 2014-15. If fine amounts are not explicitly stated in the respective code provision, charging officials may consider ten factors when determining the amount of the fine. Municipal fines not governed by Chapter 100 of the Administrative Code are generally governed by the code section that they reside or, in some cases, by agreement with a vendor.
- The City lacks a uniform citation-tracking protocol across departments. Although the Controller's Office tracks revenue from fines, fees, and forfeitures, this data comingles revenue from fees for services and does not include all fine revenue across the City. Further, some City departments issue one citation for multiple violations or do not track the revenue that is received from citations, making it difficult to tie the number and dollar amounts of citations to violations. An additional complication is that many citations are State codes, which are enforced locally with revenue either shared with or provided completely to the State.
- The City's codes, including the Health Code, include many citations that are not enforced and appear to be obsolete. For example, Article 12 of the Health Code includes a section regulating the manufacture of shoddy, a recycled wool textile that was common in the 19<sup>th</sup> century. Additionally, the City has a Port Code that is rarely enforced, and is a holdover from when the City had separate Port fire and police forces. Further, we note in this report several instances where it appears that departments are not enforcing various codes as demonstrated by the lack of citations issued for violations over the past three fiscal years.

## The City's Administrative Fines

### **Municipal Administrative Fines**

City officers or employees with authority to enforce certain ordinances (“charging officials”) may issue a citation when an individual or party has violated one or more provisions of certain City ordinances. A fine is defined by the Administrative Code<sup>5</sup> to mean the dollar amount of the administrative fine that the person cited is required to pay for violation of an ordinance as set forth by the charging official.

California Government Code Section 53069.4<sup>6</sup> and Chapter 100<sup>7</sup> of the City's Administrative Code provide the governance framework for the imposition, enforcement, collection, and administrative review of municipal “administrative” citations and fines in San Francisco. Although many municipal fines in San Francisco are considered administrative citations and therefore governed by these two code sections, other municipal fines are governed by the ordinances under which they were established as described in more detail below in the department-specific sections and in the comprehensive list, which is attached to this report. Chapter 100 of the Administrative Code only governs municipal fines when the ordinances under which they were established identify them to be “administrative fines.”

The Administrative Code also stipulates that the charging official may provide a notice of the citation to the owner of real property when there is a nexus between the violation and the real property located in the City. The charging official may also impose a lien on the property when cited consistent with Administrative Code requirements.

#### *Administrative Fine Amounts and Payment Requirements*

The Administrative Code stipulates maximum administrative fine amounts, consistent with State Code, and states that the imposition of administrative fines is “not intended to be punitive in nature, but is instead intended to compensate the public for the injury and damage caused by the prohibited conduct.”

Specifically, the code states that the amount of the fine for violation of an ordinance shall be:

- Up to \$100 for a first violation of the ordinance;
- Up to \$200 for a second violation of the same ordinance within one year of the date of the first violation; and,
- Up to \$500 for each additional violation of the same ordinance within one year of the date of a second or subsequent violation.

Further, the Administrative Code allows the charging official to take one or more of 10 factors into consideration when determining the amount of the fine. These factors include:

1. The duration of the violation;
2. The frequency, recurrence, and number of violations by the same violator;
3. The seriousness of the violation;
4. The good faith efforts of the violator to correct the violation;
5. The economic impact of the fine on the violator;
6. The injury or damage, if any, suffered by any member of the public;
7. The impact of the violation on the community;
8. The amount of City staff time, which was expended investigating or addressing the violation;
9. The amount of fines imposed by the charging official in similar situations; and,
10. Such other factors as justice may require.

Persons who are cited with administrative fines must be provided with at least 30 days for payment from the date the citation is served. Further, the Administrative Code stipulates that fines that remain unpaid 30 days after the due date shall be subject to a late payment penalty of 10 percent plus interest at the rate of one percent per month on the outstanding balance, which is added to the penalty amount from the date that payment is due. In addition, where there is a nexus between the violation and real property against which the City may impose a lien for non-payment of the citation.

The amount of unpaid fines and any applicable late payment charges constitute a debt to the City under the Administrative Code. As such, the City may file a civil action or pursue other legal remedy, such as placing a lien on real property when applicable, to collect such money.

### *Appeals and Hearing Procedures*

The Controller's Office staffs the administrative appeals process, pursuant to Administrative Code Chapter 100 related to Administrative Fines. This is further discussed in the Controller's Office section below.

## **Municipal Fine Information by Department**

### **Airport**

The San Francisco International Airport issues administrative fines for violations of the Airport's Rules and Regulations as provided under Rule 14 ("General Fines"). Violations of Rule 14 and respective administrative fines may be cumulative (one citation may contain multiple fines) and may be in addition to other civil or criminal federal, state, or local penalties. Violations fall under four categories: (1) General Conduct; (2) Parking; (3) Commercial Ground Transportation Operations; and, (4) Airfield Safety and Security.

General Conduct addresses violations by the public of rules pertaining to littering, smoking, traffic rules, and interfering with wildlife. Most of these violations carry a fine of \$100 for the first offense, \$150 for the second offense within 12 months of the first offense, and \$250 for the third offense within 12 months of the first. The Airport only receives a portion of the traffic fine revenue for on-airport violations by the public from the Superior Court of San Mateo County, which processes such fines. Traffic fines issued to permittee operators (e.g., airport shuttles, taxis, etc.) are not shared with San Mateo County. No other Airport fines are shared with San Mateo County.

Violation of parking rules carries a fine of \$50 for the first offense, \$75 for the second offense, and \$100 for the third offense.

Commercial Ground Transportation Operations rules address general operating requirements (such as operating permits and vehicle markings), conduct on airport roadways (such as bypassing the taxicab holding area, or loading and unloading passengers at inappropriate locations), limousines operating without a permit and pre-arrangement, and transportation network companies violating permit requirements. Depending on the rule section, fines are either: (1) \$100 for the first offense, \$150 for the second offense, and \$250 for the third offense; or (2) \$250 for the first offense, \$500 for the second offense, and \$750 for the third offense.



Airfield Safety and Security rules address issues including unsafe aircraft operation, failure to report accidents or extended delays, and security violations. Most Airfield Safety and Security violations carry a fine of \$750 for the first offense, \$1,000 for the second offense, and \$1,250 for the third offense. During FY 2014-15, the Airport began levying fines for rule violations by airfield operators; prior to FY 2014-15, airfield operators were only issued admonishments. The Airport also levies penalties on tenants for violating permit and/or lease terms.

### Building Inspection

The Department of Building Inspection (DBI) issues administrative penalties for work without a permit in violation of the San Francisco Building, Electrical, Plumbing, or Mechanical Codes of 2013, respectively. Code violations for work without a permit are charged at nine times the Permit Issuance Fee plus the original permit fee. Plumbing, Mechanical, and Electrical Permit Issuance Fees and original permit fees vary based on DBI fee schedules that are tied to various factors such as size of the project. Building Permit Issuance Fees are based on the valuation of the project. According to DBI staff, although San Francisco has separate Mechanical and Plumbing Codes, mechanical and plumbing violations are tracked together, so separate amounts of mechanical and plumbing violations could not be identified.

### City Administrator

The City Administrator is able to assess and cite penalties related to ordinances regarding minimum wage, paid sick leave, prevailing wage, health care security, health care accountability, fair chance, family friendly workplaces, and formula retail employee rights, which fall under the Office of Labor Standards and Enforcement (OLSE), as well as violations of entertainment regulations, which are housed within the Entertainment Commission.

Investigations into violations of the City’s employment-related ordinances, such as the Health Care Accountability Ordinance and Minimum Compensation Ordinance, can be lengthy, and take multiple years to complete. Therefore the number of citations issued by OLSE in one year may differ greatly from the amount of citation revenue brought in that same year.

For violations enforced by OLSE, violators can pay the penalty in its entirety, or can request a payment plan. Many penalties are assessed through a settlement process between OLSE and the violator. OLSE can take the case to a hearing presided by an administrative law judge.

For the Entertainment Commission, late payments can accrue penalties as defined by Administrative Code Chapter 100. The Entertainment Commission can also proceed with other forms of corrective action including suspension of permits.

### City Planning

The Planning Department assesses penalties under both the Administrative Code and the Planning Code related to short term rentals, general advertising signs, non-specialized enforcement actions, building permit applications, and code violation abatement.

Payment of citations is requested in full within 30 days of the date the Department's notice of penalties is mailed. The Department may negotiate a payment plan in some cases. Delinquent payments are referred to the Bureau of Delinquent Revenue, which can place liens on properties and perform other legal actions, as well as charge collection fees (typically 25 percent) on top of the outstanding balance.

Citations are issued most frequently for general enforcement and building code permit violation abatements. As a result, these categories generally bring in the most citation revenue, with the exception of settlement fees allocated to the Planning Department from general advertising sign lawsuits.

## Controller

The Controller's Office staffs the administrative appeals process, pursuant to Administrative Code Chapter 100 related to Administrative Fines. When the Controller's Office receives an appeal, staff notifies the issuing department of the appeal, holds the fine amount, and schedules a hearing where the Controller, Deputy Controller or contractor serves as the Hearing Officer. Upon the Hearing Officer's determination, the Controller's Office either allocates the full or partial fine amount to the issuing department or reimburses the appellant.

Under Chapter 100 of the Administrative Code, the Controller's Office has produced administrative forms and templates to carry out their Chapter 100 duties, including a hardship deposit waiver application, template for waiver determination, and templates for all notifications related to the appeals process.

The Controller's Office considers the total penalty amount of the citation in order to validate the appeal request which may consist of multiple violations. When reporting on the number of violations and associated revenue, the Controller's Office groups code violations, rather than reporting on violations by type.

The Controller's Office staffs the administrative appeals process for code violations issued by the Fire Department, Department of the Environment, Entertainment Commission, and the Office of Labor Standards Enforcement.

## Superior Court

The Superior Court functions as a collection agency for the City of San Francisco and books the revenue on behalf of the City. The Court does not have the authority to issue citations. If individuals do not pay court-ordered citations, the Court's collection programs are authorized to use tools such as additional fines or wage garnishments to motivate individuals to pay their debt. While counties are statutorily responsible for the collection of such debt, collection duties are often delegated to the courts.

Penalties can be paid in full or through an installment plan. Nonpayment results in little consequence, as the Court treats them as a collections case, which can be reported to the credit bureaus if not paid in full. If the violation goes to the Franchise Tax Board, a tax intercept can take place if a tax refund is available. For traffic fines, a driver's license hold may be put in place for non-payment.

### District Attorney

The District Attorney does not assess any municipal fines. The District Attorney can bring civil actions under State Business & Professions Code Sections 17200 and 17500, related to unfair competition and false advertising, respectively. According to the District Attorney, cases are intermittent and unpredictable; therefore the number of cases and revenue brought in varies greatly from year to year.

Defendants generally pay the entire civil penalty at the time of judgment or shortly thereafter. On occasion, payments may be made over time, with stipulations set forth in the judgment. Failure to pay the penalty would be a violation of the judgment and enforceable by the judge.

Most criminal fines and fees assessed for a criminal case are collected by the Superior Court via accounts set up through a collection agency.

### Economic and Workforce Development

The Office of Economic and Workforce Development (OEWD) enforces the Local Hiring Policy for Construction. The Policy covers City public works and improvement contracts in excess of \$400,000 advertised for bids in or after March 2011. In 2015, the Policy was amended to cover contracts in excess of \$600,000 advertised in or after August 2015. The mandatory local hiring participation level increases annually over the first seven years of implementation, up to a mandatory participation level within each trade of 50 percent of work hours performed by local residents, with no less than 25 percent of project performed by disadvantaged workers. As of March 2015, the mandatory participation level is held at 30 percent for an additional 24 months or until further Board of Supervisors action. Contractors or subcontractors who fail to satisfy the local hiring requirements must forfeit to the City an amount equal to the journeyman or apprentice prevailing wage rate for their trade for each hour that they fell short of the local hiring requirement.

According to OEWD, two of the five Local Hiring Policy-related penalties imposed in FY 2013-14 and FY 2014-15 have not yet been paid. Eight additional penalties have been imposed to date in FY 2015-16, of which five penalties have not yet been paid.

### Ethics Commission

The Ethics Commission is authorized to impose administrative fines of up to \$5,000, or three times the amount which the person failed to report or unlawfully contributed, for violations of the Campaign and Governmental Conduct Code related to campaign finance, lobbying, conflicts of interest, and governmental ethics in accordance with City Charter Section C3.699-13. The Commission is also authorized to impose late filing fees for failure to timely file various reports, including campaign reports, campaign consultant reports, lobbying reports, and annual statements of economic interests. Late fees are not included in the administrative fine amounts included in this report.

### Fire

The San Francisco Fire Code was replaced with the 2013 Fire Code in November 2013, which became operative on January 1, 2014. Under the code, a Fire official may issue a written notice of violation when they find: (1) a code violation or (2) activity being performed without a required permit or in violation of a permit.

Under Chapter 1, Section 105 of the Fire Code, operational permits are required for hot work, storage and use of liquid propane gas, use of open flame and torches in wildfire risk areas, and stationary storage of battery systems with liquid capacity greater than 50 gallons. In addition, construction permits are required for installation of car stacking parking systems in buildings.

A Fire official may issue a stop work order for work without a permit. If correction of the code violation is required, the Fire Code official may charge an administrative fee of \$1,000 for re-inspection to certify compliance. Violating the code or refusing to comply with a notice of violation is subject to a civil penalty up to \$1,000 per day that the violation is committed or permitted to continue, plus attorney's fees. Civil penalties are recovered in civil actions brought by the City in court. Failing to comply with an order or removing a posted notice or order is a misdemeanor.

## Library

The Library has the authority to assess fines under Administrative Code Sections 8.21 and 8.22, related to library fines and fees. Fines are generally cited for overdue books, lost books, visitor's library cards, lost library cards, damaged materials, and inter-library loan services.

If fines are not paid, patrons may make full or partial payment on fines. If their fines are over \$10, patrons are no longer permitted to check out library materials.

## Municipal Transportation Agency

The San Francisco Municipal Transportation Agency (MTA) assesses municipal penalties under the Transportation Code, Park Code, Golden Gate Bridge Code, Harbor Code and the Municipal Police Code. MTA code violations are related to a variety of non-moving transportation violations including traffic control, parking enforcement, and transit violations, among others. MTA may cite violations throughout the City, including on Park and Port property. Moving vehicle violations are enforced by the Police Department, not MTA. The MTA enforces non-moving transportation violations of state vehicle code, which are not included in this analysis.

The most common MTA citation issued is for vehicles parked on the street on the days and hours where parking is prohibited for street sweeping. Revenue collected from street sweeping citations is the largest share of MTA citation revenue. Other common MTA citations include failure to pay a parking meter, parking in excess of the hours permitted in a residential or carpool zone, and improper parking on grades. In addition, over the past two fiscal years, the number of fare evasion citations has greatly increased, and become one of the most commonly issued MTA citations.

The price of some citations varies depending upon whether the citation is issued within or outside of the MTA designated Downtown Core, where violations are more expensive.

Late payment penalties for violations of the Transportation Code are as follows:

- Failure to pay a citation penalty by the first due date affixed to the notice of violation shall be \$30;
- Failure to pay a citation penalty by the second due date affixed to the notice of violation shall be \$40;
- Fee to reimburse the City for collection costs incurred as a result of a citation that is neither contested or paid by the first due date affixed to the notice of violation shall be \$46; and
- Fee to reimburse the City for the costs of removing boots from vehicles is \$316.

The SFMTA offers community service in lieu of payment and payment plan options for customers with eligible citations. These options are not available if a vehicle has been booted or towed, or if the citations have been assigned to special collections.

### Police

The Police Code is comprised of numerous violations, which have either been codified by state or local statute. According to the General Counsel (City Attorney designee) for the Police Department, it is impossible to know which codes resulted from state or local legislation, and therefore the impact of citation revenue earned from each violation of local code, without manually going through each violation in the Police Code. As of the writing of this report, that information is not available.

However, the Police Department assesses municipal fines related to the Police Emergency Alarm Ordinance, which imposes fines related to false alarms. The Police Department tracks the revenue brought in from the citations, but not the number of citations issued per fiscal year. In addition, the Police Department assesses a fine of \$0.50 per every \$10 traffic citation issued, which is put toward the Department's Automated Fingerprint Fund. Although this fine is state legislated, it provides revenue to the Police Department.

## Port

There are numerous violations that can be cited under the Port code related to disorderly conduct, animals, traffic regulations, and required permits to conduct activities on Port property. As the Port Code is generally not enforced, penalties for late and non-payment are unknown.

Most violations that occur on Port property are cited under the Transportation Code, Park Code, and Harbor Code by the MTA or the Police code by the Police Department. Therefore, no citations have been issued for a majority of Port Code violations over the past three fiscal years.

Citation information below only reflects violations cited by MTA. Information for citations issued by the Police Department is not available.

Note: The revenue earned from citations includes revenue earned from citations of both municipal code and State code. However, only violations of local municipal code are counted in the total number of citations per fiscal year. The Port is not able to separate out revenue earned from violations of municipal code and State code. The Port's citation revenues are also net of numerous deductions such as state surcharges, and shares for other entities such as the Golden Gate Bridge, among others.

## Public Health

The Department of Public Health (DPH) has authority to issue fines for violations of a wide variety of San Francisco Health Code provisions. However, according to Mr. Richard Lee, Acting Director of Environmental Health, DPH primarily exercises their authority to enforce violations related to garbage and refuse, food facility permits, hazardous materials, hazardous waste generation, underground storage tanks, and licensing of massage practitioners and businesses.

DPH's Health Officer holds monthly hearings on behalf of the Director of Health and may impose fines for Health Code violations. Individuals may appeal at these hearings any fines or penalties that were assessed for not complying with inspections related to Health Code provisions.

Administrative fines, such as late-payment penalties, do not have the right to a hearing. Such fines related to hazardous materials and underground storage tanks, under Health Code Article 21, include fines for late application submittals (for temporary and full time storage facilities) and for failure to obtain approval or schedule site inspections prior to closure, removal, or modification of



underground storage tanks. The amounts associated with the administrative fines related to Health Code Article 21 are not included in this report because DPH staff stated that they did not have the resources to compile citation records in a timely manner.

Failure to pay administrative fines may result in formal enforcement action. The Tax Collector collects the administrative fines for failure to maintain adequate refuse collection service at residential and commercial properties through property tax bills. The Tax Collector allocates the portion of the property tax bill associated with the refuse fines to DPH. If a complaint is issued, the City may assess civil penalties up to \$2,000 per violation per day. For willful violations of the Health Code, the City may assess civil penalties up to \$5,000 per day.

### Public Utilities Commission

The San Francisco Public Utilities Commission (PUC) issues a charge for excess water usage among commercial (non-residential) irrigation customers. In May 2015, the PUC adopted a Drought Program to achieve a 10 percent system-wide reduction in water use and a mandatory reduction of 25 percent among irrigation customers. The excess use charge is 200 percent (two times) the applicable water rate. The PUC also charges a late payment penalty for bills that are 30 days past due, but late payments are not included in the administrative fine amounts included in this report.

### Public Works

The Department of Public Works (DPW) has the authority to assess penalties under the Administrative Code, Public Works Code, Health Code, and Police Code. The most common DPW citations have been issued for portions of the Health Code related to illegal dumping, maintenance of refuse collection services and public health nuisances, as well as portions of the Police Code related to public

littering, littering on public property, public litter receptacles, and obstruction of streets and sidewalks.

Citation recipients are given 90 days from issuance or decision of appeal to pay the amount due. In some rare cases payment plans are permitted. In the case of non-payment of administrative citations, the value of the citation is transferred to the property owner's tax bill along with an additional 12 percent administrative fee.

### Recreation and Park Department

The Recreation and Park Department (RPD) assesses penalties from the Park Code, Health Code, Transportation Code, and Police Code that occur on City park property. Fines are paid to the Superior Court or can be worked off by community service. If fines are not paid, late penalties are incurred and an arrest warrant can be issued. The offender might be required to appear in criminal court.

The Park Patrol Division of RPD administers and tracks citations. According to RPD, all citation revenue is collected by the Superior Court and RPD does not receive the revenue, nor do they know much revenue is actually collected from citations or who the funds are provided to.

### Sheriff's Department

The Sheriff's Department does not impose municipal fines or collect citation revenue from municipal fines. However, the Department does receive reimbursement funding from violations of the State Penal Code which are set, collected, and distributed by the State Superior Courts. For every \$10 in court fines or fees, \$1 goes to the DNA Fund, legislated by Penal Code 296, and managed by the Sheriff's Department's DNA Unit. The DNA Fund supports the

DNA Unit, which oversees the DNA collection from anyone arrested or convicted for a felony offense. The DNA Fund monies may *only* be used for costs associated with DNA collections including the DNA Unit's salaries and benefits, supplies, shipping costs, and equipment. The Sheriff's Department currently receives 75 percent of the fund, while the state receives 25 percent. Funding may only be used for costs of the Sheriff's Department DNA Unit.

The Sheriff's Department has received approximately \$1,080,000 from these fines since 2005. The balance in the fund is currently \$377,219.<sup>8</sup>

### **Treasurer/Tax Collector**

The Treasurer/Tax Collector assesses municipal fines under the Business and Tax Regulations Code related to violations by businesses to produce certain registration and financial information, maintain and produce records as required, and others.<sup>9</sup>

Penalties increase cumulatively by 50 percent for each subsequent violation of the same provision by the same person within a three year period. The maximum penalty that may be imposed by administrative citation in a calendar year for each type of violation is \$25,000. The Tax Collector may also assess enforcement costs, including attorney's fees, which do not count toward the \$25,000 maximum.

In FY 2012-13 and FY 2013-14, the Treasurer/Tax Collector's Bureau of Delinquent Revenue collected residual delinquent collections for the Superior Court, the terms of which were governed by a Memorandum of Understanding. However, the Department does not have specific information about the citations or revenues collected, only an aggregate amount collected by fiscal year.

## **Conclusions**

We have identified approximately 430 violations of City ordinance or contracts over the last three fiscal years that are subject to a fine. Further, we found that 1,866,614 municipal citations were issued in FY 2014-15, resulting in \$88,639,237. This represents about 1.03 percent of the City's budgeted revenues in FY 2014-15.

Of the \$88,639,237 in fine revenues in FY 2014-15, \$82,438,866 or 93 percent were due to citations issued by the San Francisco Municipal Transportation Agency (MTA). MTA citations have primarily been issued for: parking on a street during street sweeping days and hours, failure to pay a parking meter, parking in excess of the hours permitted in a residential or carpool zone, and improper parking on grades.

The City lacks a uniform citation-tracking protocol across departments. Although the Controller's Office tracks revenue from fines, fees, and forfeitures, this data comingles revenue from fees for services and does not include all fine revenue across the City. Further, some City departments issue one citation for multiple violations or do not track the revenue that is received from citations, making it difficult to tie the number and dollar amounts of citations to violations. An additional complication is that many citations are State codes, which are enforced locally with revenue either shared with or provided completely to the State.

The City's codes, including the Health Code include many citations that are not enforced and appear to be obsolete. For example, Article 12 of the Health Code includes a section regulating the manufacture of shoddy, a recycled wool textile that was common in the 19<sup>th</sup> century. Additionally, the City has a Port Code that is rarely enforced, and is a holdover from the days that the City had separate Port fire and police forces. Further, we note in this report several instances where it appears that departments are not enforcing various codes as demonstrated by the lack of citations issued for violations over the past three fiscal years.

## Recommendation

The Board of Supervisors should request the Controller to work with City departments, as part of the annual budget process, to evaluate and report to the Board on which administrative or penalties require better enforcement and which should be deleted from the Administrative Code.
