12 WHEREAS, The State Department of Education requires that this funding be provided
13 through an approved Alternative Payment Provider; and

14 WHEREAS, The Board of Supervisors has previously approved a contract for this
15 service with this contractor for the period of July 1, 2006 to June 30, 2012 in the amount of
16 \$269,624,415, on file with the Clerk of The Board of Supervisors in File No. 06-0334
17 Resolution No. 307-06; now, therefore, be it

18 RESOLVED, That the Board of Supervisors hereby approves this contract modification
19 with the Children's Council of San Francisco to provide child care services for the period from
20 July 1, 2012 through June 30, 2017, in the amount of \$240,869,365.
