Calling All Activists

The very first open hearing before the Ethics Commission on enforcement of the Sunshine Ordinance will take place on Monday, July 11, 2011, at 5:30 p.m. in City Hall, Room 408. The complaint to be heard is <u>Sue Cauthen v. San Francisco Library Commission</u>, No. 01-100115. This case promises to set the precedent for the future perception of the Sunshine Ordinance and how it is enforced.

It is well known to many activists, but fairly invisible to the citizens of San Francisco at large, that the Sunshine Ordinance in this City is less than an empty threat. The Sunshine Ordinance Task Force, influenced by the City Attorney, enforces private influence and bureaucratic power by tying up any potential activist in a wasteful morass and an energy drain from which he will likely never recover.

The New York Times, by and through their local affiliate, the Bay Citizen, first blew the whistle on March 17, 2011, in its article, "Sunshine Ordinance, Now 17 Years Old, Still Has Baby Teeth" pointing out that in "27 instances of serious violations" there has not been a single followup by the Ethics Commission. That was the article that quoted the official spokesman for the City Attorney's office that the Task Force was a "rogue, lawless jury" that tried to get "conscientious public employees fired."

The San Francisco Civil Grand Jury issued a report on the Ethics Commission and found that between 2004 and 2010 there were 18 cases that the Sunshine Task Force forwarded to the Ethics Commission requesting enforcement. In those 18 cases not only was there not a single enforcement, there was not a single hearing. It turns out that the Ethics Commission does not list enforcement of the Sunshine Ordinance among its official duties.

This first hearing on <u>Sue Cauthen v. Library Commission</u> should be the ideal opportunity to set the precedent for enforcement.

We have an egregious violation, actually preventing someone from speaking, so egregious that the Sunshine Ordinance Task Force described it as a willful violation. The Ethics Commission's Staff Report stated it, "falls below the standard of decency, good faith and right action impliedly

We have a serial, recalcitrant, and contumacious violator, the Library Commission, whose only defense against the indefensible is to state that it "stands behind [its] actions." The Library Commission just had another violation referred by the Sunshine Task Force to the Ethics Commission for enforcement on June 28, 2011, and it received the same open disdain. The Library Commission openly mocks the idea of openness with a "public comment fund" and as far as they are concerned being found guilty of sunshine complaints provides credibility with corporate privatizers and philanthropists.

We have a respectable complainant, Sue Cauthen, who does not self-identify as an activist or even a critic, and who at the time of the violation was the chair of the Library Citizens Advisory Committee appointed to advise on library issues by the Board of Supervisors. It should not matter who the complainant is because the rights of a citizen belong to all of us, especially the dissenter and those with alternate views, but a counterattack on the dignity of the complainant is always the opening gambit.

This should be an example of the proverbial "perfect storm" for enforcement of the Sunshine Ordinance. If there is not going to a strong action of enforcement in this case, when is there going to be? The activist community, advocates of open government, and anyone who cares about continuing a standard for public participation and democracy in our community cannot afford to let this chance for enforcement slip away.

⇒ A complaint against the Library Commission will be heard before the Ethics Commission on Monday, July 11, 2011, to determine whether a violation of the right to make public comment was a sufficiently egregious abridgment of open government to constitute "official misconduct." The referral by the Sunshine Ordinance Task Force found "willful failure" to comply with the Sunshine Ordinance. The Library Commission response is that it "stands behind its actions."

⇒ The Ethics Commission's staff examined the facts and issued its report which stated that the Library Commission's conduct *"falls below the standard of decency, good faith and right action impliedly required of all public officials."* To have civil public discourse, the "standard of decency" must be taken seriously.

 \Rightarrow The Library Commission has a long history of preventing public comment and a wide panoply of violations of openness, public records violations, and a contempt for public process. This is necessary for the conversion of public library assets to private fund-raising. They don't claim it is an isolated incident because they can't.

⇒ The self-styled aristocrats of the Library Commission until now have been able to deflect accountability by a counter-attack of slander and denigration of the citizens who rely on democracy. The fact that this history of counter-attacks has been largely successful is, in itself, an outrage and a scandal. Every schoolchild knows that a respect for democracy must necessarily involve a respect for the dissenting view and the minority opinion. Enforcement has gotten this far because the victim of this abuse was a distinguished chair of the Library Citizen's Advisory Committee and active in the landmarking controversy over North Beach Branch, so the motivation and the flagrancy of the violation were obvious.

 \Rightarrow There is always a justification for a denial of rights, hence, the common saying, a denial of rights for one, is a denial of rights for all. If we can't defend decency

CIRCUMCISION IS A SACRED RITE AND SHOULD NOT BE A CRIME

Faith & Values

One morning not long ago, I went to a congregant's home for a special celebration. Mike and Lisa Cohen had just had their first baby, a boy, and now, on the baby's eighth day, it was time for an ancient ceremony called Brit Milah, or Bris, the "Covenant of Circumcision.".

It was a joyous event. Friends and family poured into the Cohens' home bearing trays of food for the celebration, and gifts for the baby. There were hugs and laughter, and soon there would be bagels and cream cheese for all.

Brit Milah ceremonies such as this one are profoundly important religious ed him to Dan, one of Mike and Lisa's close friends, who sat on a special chair in front.

The person who performs circumcisions is a mohel often a physician with special training in the Jewish aspects of the procedure.

Mike and Lisa recited a prayer praising God for having instructed them to bring their child into the covenant of the Jewish people. The mohel recited a blessing of his own, then opened the baby's diaper, circumcised him, bundled him back up, and handed him to Lisa.

The procedure took about two minutes, and within another couple of minutes, the baby had quieted down and was resting comfortably in his mother's arms. In part. that might have been because we let him suck on a wine-soaked piece of gauze to soothe him while the mohel did his work.

"This child is known by

the name David Samuel Cohen," I said. "And let him also be known among our people by the name "Daveed Shmuel son of Micha'el and Leah. May it be a name that brings honor to his family and the Jewish people."

I know that the idea of circumcision may sound barbaric. But the practice is not. It is a loving way of bringing a boy into an ancient covenantal relationship with God and the Jewish people, and of marking his participation in that covenant in his very flesh. In the Bible, it seems to have been linked to fertility - it was only after Abraham circumcised himself that his wife Sarah became pregnant with Isaac and Ishmael. Unlike female genital mutilation. Jewish circumcision is not a way to limit or control the child, and it does not destroy sexual desire.

Many find the practice troubling, I believe, because

it so dramatically distinguishes religious values from commonly accepted modern American ones. America idealizes nature; Judaism and other religions try to control it and improve it. America sees happiness as the greatest goal, Judaism and other religions see holiness as far more important. Americans identify good parents as those who protect their children from all suffering; Judaism welcomes children into Jewish life with a moment of suffering, and then assures them that, with a hug from mom and a little sweet wine on their lips, it will be all OK very, very soon.

After the ceremony, everyone ate bagels and lox, and little David got more wet. sloppy kisses than his little cheeks knew what to do with. That day, the Cohen family forged one more link in an ancient and deeply hallowed chain of Jewish tradition.

I doubt I can change the

minds of those who oppose this procedure, but I want to encourage them to look at this sacred Jewish ritual in its entirety. Do you really think this is the work of barbarians? Do you really think we should see such events as criminal activity? And at the end of the day, do you really think powerful moments of celebration and sanctity such as these make the world worse than it would otherwise be?

You might say yes, but I have a feeling that, years from now, when David Cohen stands at his own son's Brit Milah ceremony, he'll feel glad to live in a nation that affords him the freedom to participate in such a meaningful rite of passage.

Ken Garcia refuses to look at history and the solutions created, housing for the wealthy has been created consistently in San Francisco, with only occasional spurts of affordable or low-middle class housing alternatives being proposed. The essential need for a roof over ones head is a primary issue for many families when they lose a job, gain another family member, or even lose a family member and have to adjust there living situation. The FLEXIBILITY and options in the housing market REQUIRES the option of RENTING vs. just BUYING into new housing stock. The lack of affordable rental units citywide was a similar situation when Parkmerced was built for that purpose. The current Parkmerced project ignores the SOUNDNESS of the existing units and offers ZERO proof of the stated "dilapidation" you note. Many families have attended the hearings noting how they LOVE there units currently and would not prefer the dense proposal shown. The term "infill" housing is being mis-used by Parkmerced developers and city proponents, and the opposition to the development being consistently castigated by the lobbyists for the project as opposing any growth. I have repeatedly noted my support for development as long as there is a proposal that includes infill, adequate up front transit linkage (to daly city bart for the SFSU, Parkmerced and future Stonestown proposals) as leverage to get the funding needed for up from transit money. To propose \$248 million for street repairs, propose 1:1 underground parking and regrading of Parkmerced's site without looking at carbon impacts and water use, and ignore the un-sustainable demolition of sound housing, over 1500 trees and open space acres for density that could just as well be situated through a plan of dispersal at Stonestown, and along EXISTING corridors of transit along Ocean, West Portal, Taraval and Judah means we are not developing sound public housing strategy that allows for denser development and increased population housing that is lacking since Parkmerced's development. The Parkmerced ownership's motives have been seriously questioned, and the lead Architec Craig Hartman of SOM has more than one frying pan in the fire (treasure island/america's cup/parkmerced I am sure that if we went back to his original concept of dealing with the existing un-retrofitted towers, an promoted a proposal that linked transit, developed equitably on multiple properties and neighborhoods, promoted infill, and looked at a slightly changed plan inclusive of the "preservation" model of sustainable adaptive re-use and infill we ALL would be more approving of the project, and not out collecting signatures to overturn ill-thought projects, while more families keep looking for housing that costs less than 50% of there income. Until we meet that issue head-on we will continue to see families leave, and create more tension between those that have a roof over their heads, and those that are trying to stay close to jobs, and reduce there commute costs. The right type of housing is why Parkmerced was originally built, what is being proposed needs to be re-thought, and the introduction of legislation preventing the destruction of sound housing is a drift I catch like the daily fog of San Francisco.... Dear President Chiu,

The proposal to enact an Ordinance to amend the Parks Code by adding Section 12.49 "to ensure equal public access to parks and recreation facilities and to prevent privatization of public parks and facilities" has a worthy purpose, but if adopted, may result in a number of unintended negative consequences, some of which that could be detrimental to the very park system which the Council wishes to protect.

The National Recreation and Park Association has closely followed the impacts of the recession on public parks and recreation agencies across America. Park and recreation departments at all levels of government are under significant stress from flat or declining budgets, and there is a high likelihood that tax-supported revenues will be restricted for the foreseeable future.

As we observe similar conditions facing other departments around the country, it is evident that park and recreation agencies need greater flexibility to enter into new cooperative agreements and reasonably adjust set fees in order to meet changing conditions and to address the extraordinary pressures caused by reduced budgets and declining tax-supported revenues. Park and recreation agencies need more flexibility rather than less to meet continuing challenges posed by the economy while providing the best possible service to the public.

We respectfully encourage the City Council to reconsider the provisions of this proposed ordinance, allowing the Department of Parks and Recreation appropriate flexibility to meet changing conditions, but with adequate oversight and accountability for decisions made. We encourage the council to join with citizens in seeking long-term sustainable funding mechanisms that allow the Department of Parks and Recreation the necessary flexibility to meet new challenges, but which maintain the high level of services that have made your City's park and recreation system admired throughout the nation.

Resolution urging the Mayor and Board of Supervisors to prioritize providing more affordable housing for transitionally aged youth, particularly their support of the goal set forth by the Mayor's Office of Housing of building 400 new units of low-income housing for this population of by the year 2015

WHEREAS, As of 2006, there are 80,000 transitional aged youth, defined as those persons between the ages of 16 and 24, living in San Francisco; and

WHEREAS, Studies have shown that, 5-10% of this population will not, and are at risk of becoming homeless, jobless or involved with the criminal justice program; and

WHEREAS, The challenges facing this population of transitionally aged youth are great: a majority will have recently cycled out of public systems, such as foster care, or have grown up in unsafe communities without sufficient access to educational opportunities or supportive families; and

WHEREAS, In 2005, the San Francisco Youth Commission passed a resolution urging the Mayor to ordain a taskforce to study and make recommendation regarding the issues that face transitionally aged youth; and in 2007 the taskforce released a report titled "A Roadmap to Improve the Life Changes of San Francisco's Most Vulnerable Young Adults," including sixteen main recommendations, key among which was the need for more accessible housing for this population; and

WHEREAS, The Mayor's Office of Housing took up this issue, and proposed the construction of 400 new housing units for transitionally aged youth by the year 2015; and

WHEREAS, Although the Mayor's Office of Housing has approved plans for the building of 88 new units for this age group, with only five years left before the proposed deadline, the city has not improved upon the 350 housing units designated to shelter an estimated 1,600 homeless youth—the same number of units available when the TAY Taskforce wrote its 2007 report; and

WHEREAS all of the major affordable housing projects completed in 2010 were designated for either senior, family—none were completed for youth; and

WHEREAS two of the planned projects-The Booker T. Washington Center and Edward II are in the process of securing approvals through city government process; and

WHEREAS these planned projects represent a substantial amount of jobs construction and permanent work in social services, and maintenance sectors; and WHEREAS both developers of these projects have strong records of respecting Union construction labor and intend to do so in these instances; and

WHEREAS Community Housing Partnership, developer of the Edward II project is a Union Shop represented by the Service Employees Union 1021 and;

WHEREAS, Service Employees Union 1021 has taken a position in support of these projects; and

WHEREAS the San Francisco Labor Council strongly commends the Mayor's Office of Housing both for the initiative they took in taking up this project as well as the progress they have made,

THEREFORE BE IT RESOLVED that the Board of Supervisors approve all the affordable housing projects designated for transitionally aged youth put forth by the Mayor's Office of Housing and support this agency in their work to improve the living situations of many TAY youth; and

BE IT FINALLY RESOLVED, that the Mayor and the Board of Supervisors make accomplishing the other recommendations of the Transitionally Aged Youth Task Force a priority, especially the creation of a citywide directive to coordinate the various services already in place for this age group.

ANNUAL WORK PLAN, FISCAL YEAR 2011-12

Introduction

The City Services Auditor (CSA) develops its Annual Work Plan by considering audits and other responsibilities mandated by the City Charter and municipal codes, the results of a limited risk assessment, and input from City management, leadership, and stakeholders. The Work Plan may change during the fiscal year as circumstances dictate. Quarterly reassessment of risk, requests from City leadership, changes within City organizations or operations, and available CSA staff resources can result in changes to the plan.

MISSION

The mission of the Office of the Controller (Controller's Office) of the City and County of San Francisco is to ensure the City's financial integrity and promote efficient, effective, and accountable government. The Controller's Office's vision is to be a model for good government and to make the City a better place.

The City Services Auditor (CSA) was created within the Controller's Office through a 2003 Charter amendment that envisions a broad effort to measure, audit, and report on San Francisco's public services and government performance. The mandate is to analyze the City's public service delivery, compare and benchmark San Francisco to best practices nationwide, provide information to citizens in new ways, and help drive improvements in City government. The City Services Auditor is among the most ambitious voter-approved efforts of its kind in local government.

AUTHORITY

CSA has broad authority for:

- Reporting on the level and effectiveness of San Francisco's public services and benchmarking the City to other public agencies and jurisdictions.
- Conducting financial and performance audits of City departments, contractors, and functions to assess efficiency and effectiveness of processes and services.
- Operating a whistleblower hotline and website and investigating reports of waste, fraud, and abuse of City resources.
- Ensuring the financial integrity and improving the overall performance and efficiency of City government.

RESOURCES

CSA is funded through a commitment of two tenths of one percent of the City's annual budget. In fiscal year 2011-2012, approximately \$11.6 million is budgeted for the City Services Auditor functions under the Charter requirement. CSA has approximately 50 full time equivalent staff including auditors, performance analysts, project managers, and operations staff. CSA conducts its work pursuant to professional auditing and analysis standards which require competence, integrity, objectivity, and independence.

CSA performs a variety of important services for city government. Our audit group has a wide range of expertise in performance auditing and financial and compliance auditing, and a growing ability to audit large data sets and information technology systems. Our performance group does evaluation, business process analysis, policy analysis, and organizational development and implementation. We are able to procure expert professional services where needed and manage technical and consultant contracts efficiently on behalf of other city departments. Where multiple city agencies or the city as a whole have similar needs or challenges, we work to deliver common solutions and reduce duplication of effort.

Fiscal Year 2010-2011 Accomplishments

AUDITS UNIT

During fiscal year 2010-2011, the Audits Unit completed, or made significant progress on many of its initiatives. For example, the Audits Unit:

- Received a rating of "full compliance" on its External Quality Control Review (peer review) issued by the Association of Local Government Auditors.
- Successfully completed a comprehensive survey of all departments to document all cash collection locations throughout the City and developed a cash receipts program in which ten locations were audited to assess the cash handling processes.
- Completed a payroll audit of the Fire Department, which highlighted inconsistent, erroneous and informal
 practices of the payroll operations within the Department, exposed unauthorized additional benefits some public
 safety employees receive upon retirement and demonstrated limitations in the City's payroll system.
- Issued an audit of the Sustainable Streets Division of the San Francisco Municipal Transportation Agency which
 identified more than a half million dollars in savings that could be realized each year if the City were not leasing
 parking garages to nonprofit corporations.
- Completed an audit of the City's Care Not Cash program and the effect that the implementation of this program
 has had on the overall delivery of services to the homeless population.

CITY PERFORMANCE UNIT

During fiscal year 2010-2011, the City Performance and Operations Units' work highlights include:

- As an outgrowth of our work with the San Francisco Police Department (SFPD) and Police Commission we
 created new databases to track incidents on Muni routes so that SFPD resources can be deployed to reduce
 crime incidence on public transit. We created, installed and trained SFPD users on a shared database to manage
 casework and related information among the investigative units.
- Worked with the Department of Public Health (DPH) on an ambitious project to bring together primary care treatment and mental health treatment into a single integrated system of care. Analysis of all the DPH clinics was completed in FY11 and training in new and innovative patient care models is well underway for the clinical and behavioral health staff who are delivering these services.
- In partnership with the Municipal Transportation Agency (MTA), CSA moved through the next stages of the Transit Effectiveness Project (TEP) by completing an implementation plan and starting the environmental analysis needed to carry out the TEP. This project lays out critical improvements to MUNI's routes, systems and service delivery for the next five years and beyond.
- Worked to make City services and public policy issues more accessible to citizens by publishing a bimonthly *Government Barometer* of critical performance measures and a report of survey results on how people view the City's street cleaning and maintenance efforts.
- Coordinated development of the City's Five Year Financial Plan by working with a dozen large city agencies and the Mayor's Office to project future public service needs, model revenue and expenditure trends and problemsolve for the gaps that can be predicted over the coming five year period. The plan is required by a new Charter amendment and is a first for San Francisco.

Fiscal Year 2011-2012 Priorities

CSA's highest priority initiatives for FY 2011-12 include:

1. Capital Improvement Audit Program

CSA continues to develop its capacity to provide audit, oversight, and technical assistance services related to the City's significant portfolio of capital improvement programs, including voter-approved bond programs.

CSA's work involving the City's capital programs will include: audits of construction management and general construction contracts; audits of the operations of relevant City contract administration units; analysis of project performance tracking and reporting; and follow-up reviews of audit recommendations published by CSA in recent years. We will be analyzing the best practices followed by city departments managing construction programs and working to ensure that their systems and lessons benefit other projects. We plan to publish an easy-to-read summary of the status of capital projects that informs the public and stakeholders about whether capital programs are achieving scope, schedule and budget as planned.

2. Municipal Transportation Agency Audits and Projects

MTA Overview and Division Audit – CSA will conduct the second of a series of division audits called for in MTA's threeyear Audit Plan, focusing on the Enforcement section of the Safety, Training, Security and Enforcement Division.

Transit Effectiveness Project Implementation – CSA will continue work on the Transit Effectiveness Project (TEP) in coordination with the MTA by establishing a consulting contract for TEP environmental review and proceeding through the California Environmental Quality Act analysis needed to move forward with planned changes to the system, routes and services delivered by Muni.

3. Substance Abuse Evaluation

An ongoing analysis project will determine whether the City's substance abuse treatment services are optimally effective in responding to the long-term nature of recovery and addiction, and make recommendations to improve the system. This evaluation is assessing current and former clients three times over 18 months and examining how they access, participate in and sustain services; the typical pathways of recovery/relapse; and related impacts on the City's health, human, and public safety services. The first data and analytical reports from the evaluation will be published in FY12.

4. Public Health Services and Cost Recovery

CSA continues to collaborate with the Department of Public Health to implement a new public health care delivery model which integrates behavioral health with the primary care system. Integrated care is being implemented in all DPH primary care clinics and has led to significant changes in patient treatment, intake, staffing, training, and information technology in the City's clinics. Integrated care improves health outcomes, patient access to care, and the efficiency and cost of the public health system. In a related project, CSA is working with the department to enable more nonprofits to become certified as Medi-Cal providers and increase revenues that can be claimed for mental health services.

5. General Hospital Audits and Projects

CSA has previously worked with San Francisco General Hospital on analyses of revenue, improving the rate of cost recovery by the hospital and improving purchasing and materials cost management. In FY12, we will expand this area of work to help the City understand and control additional major drivers of SFGH's costs. Looking ahead to the move to the new hospital facilities that are now under construction, DPH will be exploring new programs, staffing configurations, financial management and many other redesign needs. SFGH is already a leader in patient and health outcomes and with the new facilities can become a best-in-class hospital for financial and cost management. The goal of this work is to keep the acute care hospital accessible and affordable for the City's needs over the long run while maintaining the highest standards of care.

6. City Employee and Retiree Health Benefits Analysis

The Controller's Office, working together with the Health Services System, Human Resources Department, and other city agencies and stakeholders will undertake an analysis of the City's employee and retiree health benefits. Looking towards Health Care Reform mandates and the need to reduce the unsustainable growth rate of the City's medical benefit costs, we will examine an array of options to manage both costs and outcomes, including health and wellness programs, accountable care organizations, plan design options, administrative and contractor management efficiencies, and others.

7. Contracting Process Improvement Program

The Controller's Office, the Office of Contract Administration (OCA), and the Human Rights Commission (HRC) along with other city agencies and stakeholders are working to enhance the quality and efficiency of City contracting. The project seeks to reduce the complexity and length of the City's contracting process through: (1) streamlining contracting compliance requirements and processes; (2) building the City's ability to achieve policy and business-related outcomes through its contracts; and (3) improving quality and decreasing costs through increased vendor competition and other efforts. In FY12, the next stages of this project will seek to leverage the City's buying power with new contracts and use new data analyses to control costs and insure contract compliance.

8. Whistleblower Program

The City's Whistleblower Program receives, investigates or refers, and tracks complaints about employee misconduct, the quality and delivery of government services, wasteful and inefficient City government practices, misuse of City government funds and resources, and other improper activities by City government vendors and contractors.

9. Performance Management and Measurement

Charter Appendix F charges CSA with measuring the level, efficiency, and effectiveness of San Francisco's public services, benchmarking San Francisco to comparable organizations, and reporting on the City's ability to attain established performance standards. Benchmarking is central element of this mandate and in FY11-12 CSA will develop a new ongoing performance report comparing San Francisco services to peer governments. The report will become a regular part of the Division's performance measurement, reporting and data validation efforts. CSA also has ongoing programs to rate, against established performance standards, San Francisco's street and sidewalk cleanliness, including graffiti incidence and litter, and park cleanliness, covering playing fields, playgrounds, bathrooms, and many other features.

10. City Survey 2011

The biennial Controller's City Survey report will be issued in the summer of 2011. The survey is designed to help improve the City's service delivery by measuring resident satisfaction and community opinion. The survey asks residents about a variety of the most common services that people use or experience day to day such as public safety, public transportation, street and sidewalk cleanliness, pavement condition, services for children, recreation and parks, libraries, and access to technology.

11. Revenue Control Audits

Citywide Cash Collection Points – CSA will continue its annual audit program which tests ten or more cash collection locations across the City to assess the oversight of cash handling on a citywide basis.

Public Utilities Commission Billing Process – CSA will conduct an audit of the Public Utilities Commission's (PUC) billing processes and procedures with a focus on data mining and analysis techniques to probe PUC water and sewer customer database records for appropriateness of customer-type designation.

Airport Property and Operations Management – CSA will conduct multiple concession audits of airport tenants, including airlines and retail shops, to confirm they are accurately tracking and reporting their revenues and making appropriate revenue-sharing payments to the City in compliance with their leases.

12. Payroll Audits

CSA maintains an ongoing program of auditing the payroll operations of departments across the City. These audits analyze various aspects of the time reporting and payment procedures of departments including timekeeping by staff, use of differential pay, premium pay, overtime, per diems, and other special pay types. Payroll audits are planned for Laguna Honda Hospital and the San Francisco Municipal Transportation Agency

13. Nonprofit Accountability and Evaluation

CSA will continue ongoing work to improve accountability, capacity, and results among the City's nonprofit service providers as they cope with reduced budgets and increased service needs in the current economic climate. CSA's Nonprofit Monitoring and Capacity Building Program establishes fiscal and compliance standards, coordinates City monitoring of its contractors, and provides training and technical assistance for contractors and City staff. Training topics include board governance, budgets, financial reporting, and cost allocation. In FY2011-12, CSA is also evaluating effectiveness of, and working to improve performance measurement in, non-profit organizations contracted by the City in the areas of violence prevention and youth workforce development.

14. Public Safety Services

State law changes and a variety of other factors are projected to increase the demands on San Francisco's public safety services in FY12 including Police, Courts, Sheriff (jail population) and Probation. CSA will work with the public safety departments to understand and predict service needs, reduce costs-per-case and improve outcomes for the City and the people involved in the justice system.

15. Redevelopment Agency Audits

The Redevelopment Agency will provide funding for CSA to conduct audits of its operational procedures and the outcomes of its work related to specific project areas in the Western Addition and Bayview Hunters Point neighborhoods. CSA may also assist the agency in a review of its planning for, and issuance of, debt that funds its activities.

Charter Amendment revising employee and retiree benefits

Dear Clerk of the Board of Supervisors:

The proposed charter amendment on the Board Calendar for July 12, 2011 came from prolonged negotiations between the City and employee unions to reduce long term benefit costs.

Since the City provides nearly 83% of the funding for the System's benefits and 100% of the cost of its administration, the City bargained for a change in the Health Service Board's composition.

The amendment revises the makeup of the Health Service Board so that the City has 3 votes (an insurance expert, a medical expert and a Supervisor), City employees and retirees elect 3 members and the seventh member is appointed, subject to the approval of the previously mentioned 6 members, by the Controller. Many retirees oppose changing the Board composition in this manner. I, along with numerous other retirees do not.

I have been a member of the Health Service System for over 51 years - 39 plus as an employee, primarily in the Office of the Controller, and 12 as a retiree. For 44 of those 51 years the System was administered by 4 City appointees - an insurance expert, a medical expert, a Supervisor and the City Attorney - and 3 elected by employees and retirees. The Retirement System Board is similarly governed - 3 Mayoral appointees with specific expertise, a Supervisor and 3 elected members.

During the period 1957 through 2004 with the City having a majority of votes on the Board, employees and retirees were fairly treated, received excellent benefits and enjoyed generally reasonable health and vision care premiums. In 2004 the City Attorney was replaced on the Health Service Board by an additional elected member. However, I can think of no instance where members and dependents have either suffered from or been advantaged by the change though our co-pays and prescription drug costs have increased significantly since the elected members gained the majority.

Some of my fellow retirees feel that the change proposed in the legislation before you is not in their best interests. I disagree because: 1) the various funding mechanisms that keep retiree out of pocket premiums at a reasonable level are unchanged; 2) the 10-County survey which sets the amount the City contributes is retained; 3) parity that matches retiree premiums with active employee premiums is retained; 4) Charter provisions that credit retiree Medicare payments against our HSS premiums and the provision for the City paying 50% of any of our remaining premium costs remain unchanged.

I am a loss to understand how we retirees are adversely affected by this change and I would respectfully urge you to send the Charter amendment to the voters as it is currently written.

I have challenged from the start the 2011 MOU between the Controller's City Service Auditor (2003 Prop C) and the Revenue Bond Oversight Committee. The RBOC (2002 Prop P) is supposed to use outside consultants and be independent. Read 2002 Proposition P.

In 2011 the RBOC the issued an MOU with the CSA. Basically turning the entire RBOC contracting process over to the Controller's office (CSA). This also would apparently allow an elected official of the RBOC to bypass the need for an agendized item (debate and public input) to issue a work or purchase orders. This relationship is wrong for many, many reasons, especially the complete wiping away of the mandate of the RBOC to remain independent, use outside consultants, and be representative of all stakeholders. This MOU, in effect, puts the General Obligation Bond Oversight Committee over the RBOC (see URL and quote below). Never intended by 2002 Proposition P. Read C.

The CSA is funded by 1/5th of 1% of all City budgets including the SFPUC. Dependence. On its own dime the CSA can investigate any and all committees and organizations in SF. It does not need to capture the RBOC nor take RBOC debt funding (specifically excluded in 2003 C). For the RBOC to remain true to P (independent and use outside consultants) it must abandon this MOU with the CSA and return to the path of hiring such independent, outside, and capable entities as the University of California at Berkeley (contract process mysteriously terminated in early 2011).

"With the passage of Proposition C in 2003, CGOBOC's duties greatly expanded. Under authority of the Charter (Appendix § F1. 111 11), the nine-member committee was assigned a secondary function as "Citizens Audit Review Board" (CARB), effective July 1, 2004. Serving in that capacity, in addition to existing duties, the committee was tasked with oversight of the City Services Auditor division of the Controller's Office."

On the eve of release of a new Civil Grand Jury report concerning San Francisco's whistleblower program expected to be released tomorrow, I thought I'd share with you a transcript of the April 28 meeting of the Citizen's General Obligation Bond Oversight Committee (CGOBOC), which hearing was to focus on the whistleblower program's processes and policies.

Not once during the meeting did this committee discuss the number of whistleblower complaints filed each year, nor did they discuss how many of the complaints filed involved "high risk," "medium-risk," or "low risk" cases, as if the CGOBOC committee member assigned to act as a "liaison" between CGOBOC and the City Controller's Office — Mr. John Madden — never bothered to ask these questions himself. Maybe he didn't want to ask these questions, since Madden is one of two appointees to CGOBOC appointed by the City Controller himself. Maybe Madden concluded that there's no point biting the hand that appoints you to a plum Committee.

Sadly, it took CGOBOC seven full years after the passage of Proposition "C" in 2003 to even create the subcommittee authorized by Prop C to act as an oversight committee over the City's whistleblower program. After just two or three CGOBOC meetings where the whistleblower program has even been discussed, Madden's pathetic report, and the CGOBOC member's lame hearing on April 28, sheds doubt on the effectiveness of the program.

Some highlights of this transcript include:

• In his folksy style, Madden believes the Controller shouldn't go around shutting off water in cases involving City gardeners accused of wasting water.

• Madden stated that the Whistle \blower Program is set up to bring ineptitude and outright larceny to the public eye. After bringing it to the public's attention, he believes resolution to any problems are outside the purview of the Controller. Huh? This is completely contrary to what voters thought they were approving in 2003.

• Madden notes that whistleblowers who are seen as having "finked" on a coworker may experience various forms of retaliation, including having "sand put

in your sandwich," or being moved to a smaller cubicle, but that retaliation is difficult to prove. Madden never discussed that retaliation often involves wrongful employment termination of whistleblowers.

• Madden offered no explanation about what he meant when he said that the whistleblower protections built into the law are "not absolute."

• Madden says that whistleblower complaints referred to a City department for resolution "stops somewhere, I guess." When did it become OK for a subcommittee charged with oversight to resort to "guessing"?

• Tonia Lediju, the manager of the City Services Auditor program and the Controller's Whistleblower Program, acknowledged that the Controller's Office only does random follow-up on cases referred to City Departments for investigation.

[As an aside, Lediju conveniently did NOT admit to CGOBOC during this hearing (as she admitted on December 3, 2010), that the Whistleblower Program had NOT investigated Drs. Kerr's and Rivero's whistleblower complaint on the LHH patient gift fund, and for his part, Mr. Madden didn't mention that the Whistleblower Program had not investigated the Kerr-Rivero patient gift fund complaint, either. Maybe Lediju didn't want to have to answer any questions about just how "random" the whole program is.]

• Madden admits he did not select the three whistleblower cases he reviewed; instead he asked the Controller's office to select the three cases for him [how many times do we have to confront the fox guarding the henhouse?]. He subsequently stated during the hearing that he had NOT reviewed the Controller's investigative file of the Laguna Honda Hospital patient gift fund whistleblower complaint; he only "looked at" the Controller's November 22, 2010 audit report of the patient gift fund.

Kerr's and Rivero's testimony during this hearing is compelling reading.

The transcript illustrates the many, many problems with San Francisco's Whistleblower Program, and that (so far), the oversight body charged with keeping tabs on the program simply isn't prepared to make recommendations for substantial reform to the program.

Let's see what the Grand Jury has to say about all of this.

From reading the newspapers one gets the impression that the availability of State and federal subsidies is increasingly "iffy".

Absent guarantees of full federal and State participation, approving a \$233.5 million tunneling contract could therefore prove to be either very expensive or very risky or both. If the bidders have been asked to hold their bids until next December it could account for the \$8 million overrun of the EE. If the plan is to certify the Contract and issue the Notice to Proceed without waiting for either full State participation or the Full Funding Grant Agreement, the premium price would be replaced by a very large risk to CCSF. I'm sure this comes as no surprise to any of you.
