



In response to Resolution #050396, I am enclosing a quarterly report to show Laguna Honda Hospital and Rehabilitation Center's compliance with the reversal of the Admission Policy priorities that became effective February 22, 2005.

On February 17, 2005, Mayor Newsom directed DPH to allow Laguna Honda (LH) to reverse the Admission Policy priorities back to the pre-March 2004 priorities. Since that time, the annual percentage of patients coming to Laguna Honda from San Francisco General Hospital (SFGH) has ranged from 59-63%. The annual percentage and current year rates are as follows:

The age distribution shows an increased trend of residents over 50 years of age. In 2004, 83% of the residents were over 50 years of age, compared to 89% of the residents in this category for 2012.

Sec. 1: EXECUTIVE SUMMARY:

The Significant Events/Accomplishments of the VAC 2012 Administration Year are summarized in items 'a' through 'e', below.

#### (a) A year of TRANSITION

2012 was once again a year of significant transition for the VAC. It included significant changes in both Commission Personnel as well as mid-term Leadership changes, (See Sec., 2, below). By the end of 2012, Commission strength stood at 15 members, with TWO vacancies (i.e. a Mayoral appointed seat, and BOS Seat #2).

#### (b) Commission DIVERSITY

In its current configuration, the SFVAC meets or exceeds all diversity requirements as per City Code and our By-Laws. We have Female veteran appointees by both the BOS and by the Mayor. We have disabled vets as required. Aside from specific requirements our commission includes a strong mix of ages, eras of service, racial/ethnic diversity, and LGBT Community representation.

#### (c) Major GOALS for the 2012 Administrative Year

The primary GOALS of the Commission (for 2012), were articulated in the January General Meeting. They included:

- > Review/Update VAC By-laws. (Accomplished in November, 2012 see item 'e' of Sec. 1, below).
- > Lobby for Veterans use of the SF Veterans Building. (See item 'a', Section 5, below).
- > Increase effectiveness & visibility of the VAC (See Section 6, below)

#### (d) First VAC Committee Meetings

Early in 2012, a **BYLAWS REVISION COMMITTEE** was established, with Comm. S. Noetzel as Chair. The Committee accomplished its work during five (5) Public Meetings during the year, each scheduled and run in accordance with all Public Notice requirements — thereby representing the first formally structured Public-access Committee Meetings in the history of the SFVAC. (See item 'e', Sec. 1, below, Re: **By-Laws Revision as submitted by Committee**).

In December of 2012, the COMMITTEE on WOMEN'S ISSUES Within the Veterans and Military Community (Chaired by Comm. D. GUY) also met in a formal Public Meeting. During their initial meeting they established that their initial priority issues would be Women's' Health care and Sexual Trauma in the military. Additional issues would include Homeless Female veterans, and the high rate of unemployment for female veterans. Comm. Guy announced that the Committee plans to re-form during the 2013 Administrative year, for continuing work on these issues.

#### (e) Major By-Laws Revision

In the November 2012 General Meeting, after considerable study and discussion of the extensive RECCOMENDATIONS of the BYLAWS REVISION COMMITTEE, the Commission voted to ADOPT the REVISED COMMISSION BYLAWS, as per Committee recommendation. The new By-Laws include re-distribution of duties and responsibilities of the various Officers to 'spread the work-load', and encourage greater participation among the membership. A copy of the COMMISSION BYLAWS (as adopted) are now available in the SFVAC WEBSITE.

#### Sec. 2: Commission LEADERSHIP and PERSONNEL CHANGES of 2012

As per VAC By laws, we started with our annual Election of Officers process, which eventually included an election resulting in the installation of Commissioner JOHN CALDERA as President; Comm. Anthony ALFIDI, Vice President, and Comm. Stephen NOETZEL as Secretary.

In April Commissioner Amber ROSE resigned from the Commission stating that her personal responsibilities required her full attention and she could not devote the required time and commitment to the VAC.

In May, Commissioner and Vice President Anthony ALFIDI resigned, (from BOS Seat #3) indicating that he was unhappy with the recent direction of the Commission. During the June VAC meeting, replacement nominations were made, an election was held and Commissioner Eduardo Ramirez was elected as interim Vice-President for the balance of the 2012 term. On 5/16/12 Ms. Ann WEEBY was appointed to the Commission (by Mayor Lee) to fill the seat vacated by Comm. ROSE.

In June, **Commissioner Michael THOMPSON** resigned (from BOS Seat #2) of the Commission due to personal reasons. At end of 2012, Seat #2 remains opened.

During the September VAC meeting, Commissioner John CALDERA resigned as President.

During the October VAC meeting, after nominations were made, an election was held and Commissioner Eduardo Ramirez was elected as interim PRESIDENT for the balance of the 2012 term.

On 12/4/12 the BOS appointed three new Commissioners, as follows.

Commissioner Michael MAFFEI was appointed to BOS Seat #9, replacing Comm. Dara WONG, whose Commission had expired. Commissioner John GALLAGHER was appointed to BOS Seat #6, replacing Comm. George GIBBS whose Commission had expired, and

Commissioner Lee BURNETTE was appointed to BOS Seat #3, replacing Comm. Anthony ALFIDI who had retired in May.

**Commissioner Chris GRUWELL** resigned from the Commission, effective 12/31/12. At end of 2012, this Mayor-appointed seat remains opened.

In summary, the 'transition of 2012' included appointment of four (4) new Commissioners.

By the end of 2012, Commission strength stood at 15 members, with a Mayoral appointed seat, and BOS Seat #2 vacant.

#### Sec. 3: Significant ACTIONS taken by the VAC in 2012

#### (a) 2011 ANNUAL REPORT

On 16 January, 2012, the SFVAC submitted its **ANNUALREPORT** (for 2011) as required by its Charter, and by City Code. The 6-page report, signed by (retiring) President Raymond WONG, included an Executive Summary, and 5 additional elements to describe the work of the Commission during the 2011 Administrative year.

#### (b) RESOLUTIONS, ENDORSEMENTS and ADVICE LETTERS to Mayor and Board of Supervisors (2012)

- RESOLUTION advocating for the addition of a VETERANS FITNESS AND WELLNESS CENTER in the Retrofit Plans for the War Memorial Veterans Building. In the February 2012 General Meeting, after considerable investigation and discussion, the VAC approved the aforementioned RESOLUTION. Subsequently, a Letter of Advice (dtd. 30 April, 2012), signed by VAC President John Caldera, was forwarded to the Mayor Edwin Lee and Board of Supervisors, urging their support for this important plan, and more specifically, to facilitate a Joint Meeting to bring together all parties with a stake in the future of the building. Copies of the letter, with its attached RESOLUTION in Support of Construction of a Fitness and Wellness Center in the War Memorial Veterans Building, were forwarded to the War Memorial Board of Trustees, the leadership of the American Legion War Memorial Commission, and the director of the VA medical Center at Ft. Miley. There has been no formal response on this matter, from either the Office of the Mayor, or the Board of Supervisors.
- Endorsement of initiative to name US Naval ship THE USS HARVEY MILK. In the May, 2012 General Meeting, after considerable investigation and discussion, the VAC approved a RESOLUTION in support of

a Board of Supervisors Resolution (as authored by Supervisor Weiner) which urged the Secretary of the Navy to christen a ship as the "USS Harvey Milk"

Censure of Commission President. In the June, 2012 General Meeting, after considerable investigation and discussion, the VAC approved a RESOLUTION CENSURE its President (Comm. Caldera) for overstepping his authority in the matter of seeking Office Space for the SFVAC in City Hall. The Resolution directed the President to "cease and desist from any action that exceeds specific authority provided by the Commission, on this and all other matters." By a raised-hand vote, the MOTION to CENSURE President Caldera overwhelmingly passed, with all Commissioners voting in favor, and one abstention.

#### (c) VETERANS RELATED LEGISLATION

During 2012, the SFVAC voted its SUPPORT (in the form of Resolutions, Endorsements, and Advice Letters to the Mayor and Board of Supervisors), for several specific pieces of legislation, as summarized below:

- <u>US House Resolution 3435</u>: Proposed Federal Legislation titled: Sexual Assault Training Oversight and Prevention Act. (i.e. the S.T.O.P. Act) as introduced by Congresswoman Jackie Speier. Passage would institute new rules within the military to protect service members against rape, sexual harassment, hazing and all remaining abusive practices experienced by service-members.
- CA Senate Bill SB661: Proposed State Legislation that Restricts Protests and Demonstrations at Military Funerals. This bill is a Re-write of an earlier Bill that was VETOED by Governor Brown under Freedom of Speech consideration. The NEW Bill (SB661) includes greater protection for grieving families to honor and bury their fallen loved ones in private and respectful ceremonies.
- US House Bill 210: Proposed Federal Legislation titled: The Fairness to Filipino Veterans Bill (which now has over 90 co-sponsors in the House). In its General Meeting of 3/5/12, the VAC passed a Resolution to Advise the City Government of San Francisco to support a US SENATE version of the House Bill, so that this matter can move forward to passage. In this regard, a Letter of Advice (dtd. 25 April, 2012), signed by VAC President John Caldera, was forwarded to the Mayor Edwin Lee and Board of Supervisors, urging them to author a Resolution in support of Senate Companion Bill to match House Version of Filipino Veterans Fairness Act. There has been no formal response on this matter, from either the Office of the Mayor, or the Board of Supervisors. Copies of the letter were also sent to Senators Feinstein and Boxer, in the hope that they might take action and draft the requested Senate Bill.

#### (d) ETHICS TRAINING

On 2/28/12 the City of San Francisco offered an evening of training for City Employees and members of its various Commissions, Agencies and Boards. A total of seven (7) VAC Commissioners (Alfidi, Caldera, Crichlow, Noetzel, Ramirez, D. Wong and R. Wong) attended the training session, thereby earning a Certificate of Ethics Training with respect to the California Brown Act and the San Francisco Sunshine Ordinance. The training is offered every two years and it represents a base line of critical knowledge in the little-known laws and regulations that govern interaction between Commissioners.

#### (e) SPRING RESOURCE FAIR IN VETERANS BUILDING

On 3/2/12 the entire War Memorial Veterans Building was transformed into a major Resource and Job Fair. The event was fully endorsed by the SFVAC as several Commissioners worked closely with the Community Covenant organizations that planned and sponsored the event. Some 55 vendors (i.e. Service Providers) attended and participated, including some 25 Employers. Additional Resource vendors included tables for all Bay Area Colleges and Universities (public and Private). Some 400 participants attended at least a portion of the proceedings as numerous Résumé's were circulated; Initial employment interviews conducted (including 2 veterans "hired on the spot"), and at least 6 veterans were signed up for VA services. In short, an extremely successful Event, by any standard of measurement.

#### Sec. 4: ANCILIARY EVENTS undertaken by the VAC in 2013.

- (a) City Sponsored Events for MEMORIAL DAY, and VETERANS DAY.
  - By long-standing tradition, (if not by specific mandate), members of the SFVAC have organized and produced, (individually and working in concert), the TWO major Annual San Francisco EVENTS that honor the military service and sacrifice of its Veterans and Military Community.
  - On Monday, the 28<sup>th</sup> of May, 2012 (Memorial Day), led by Comm. Wallace LEVIN, members of the Commission organized planned and participated in the annual MEMORIAL DAY ceremonies at the S.F. Presidio. Once again, Comm. Levin presided over a stirring event in commemoration of the many Armed Services men and women who have paid the ultimate sacrifice in defense of our nation. Many of the Commissioners participated in various roles to assure that the parade and ceremonies proceeded exactly as planned. The Mayor and several S.F. Supervisors commended Comm. Levin for another outstanding memorial event at the Presidio.

On Sunday, the 11<sup>th</sup> of November, 2012 (Veterans Day), led by Comm. Wallace LEVIN, members of the Commission (and a variety of volunteers) organized planned and participated in another highly successful annual VETERANS DAY PARADE in downtown San Francisco.

#### (b) TOWN HALL Meetings.

Throughout the year, in addition to his many other duties, Comm. Eddie Ramirez has continued to run his TOWN HALL MEETINGS on the 4<sup>th</sup> Wednesday of each month, in the War Memorial Veterans Building. Hosting a morning session (mostly for Homeless and/or Job Seeking Veterans), as well as an Evening Session, Comm. Ramirez has featured dozens of Speakers, Educators, and Service Providers for small-group settings with Veterans who need help to improve their lives

#### (c) Mid-Term Presidential ELECTION.

At the outset of the September, 2012 General Meeting, Commission President John Caldera resigned as President of the Commission. Vice-President Eduardo RAMIREZ was elevated to the position of Acting President. In a subsequent ELECTION (during the October General Meeting), Comm. Ramirez was ELECTED as Interim President, to serve in that capacity for the remaining portion of the 2012 Administration Year.

#### (d) Re-Establishment of City Policy on Fee Exemption for Veterans.

During the September, 2012 General Meeting, Guest (and Veteran) David Glass explained a problem has recently experienced with the City Health Department. As a long-term food vendor (at numerous public Concerts/Events) he has, for many years, enjoyed the State of California VETERANS EXEMPTION (of fees) in connection with his business, as provided in the California Code (Sec. 16102). Mr. Glass claimed that in contradiction to the law. City Health Department has arbitrarily leveed substantial "inspection fees" to his Veteran Owned business. After making his case before the Commission. President Eduardo Ramirez appointed Comm, Jordan TOWERS to be the LEAD person to fully research this item, and report his findings to the Commission in the next meeting. In the December General Meeting, Comm. Towers reported a very positive outcome in this case. Specifically, he reported that he had first asked the City Attorney to look at the matter and issue a Legal Opinion on weather the City Health Department was in compliance with the State mandated Veterans Fee Exemptions in this matter. Comm. Towers further reported that the City Attorney issued a Legal Opinion that completely SUPPORTED the fee exemption, and that the City Health Department was NOT IN COMPLIANCE with State Law in attempting to levee inspection fees on Mr. Glass or other Vendors who have proven their status as Veterans of US Military Service. Finally, Comm. Towers reported that an Administrator from the City Health Department has informed Mr. Glass of their error, and will discontinue its recent improper practices in this regard. The Commission expressed its collective thanks to Comm. Towers for his excellent work in gaining this victory on behalf of the Veterans Community in San Francisco.

#### Sec. 5: General Meetings - Attendance and Guests

#### (a) MEETING GUESTS and PUBLIC COMMENTARY.

The monthly General Meetings of the VAC, traditionally held at 6pm, in room 104 of the War Memorial Veterans Building, on the first Monday of every month, were once again attended by a wide variety of guests at every meeting. They came to initiate and strengthen connection between a variety of public and private organizations (and the Commission) to provide enhanced services to the Veterans Community of San Francisco. Some of the most frequent meeting guests were bay area Veterans who were already active in Veterans issues. As in the past, some guests were later appointed to seats on the VAC. Officers of the American Legion War Memorial Commission attended frequently to act as lialson between the ALWMC and the VAC on important issues pertaining to Retrofit Plans and Post-Retrofit Building Use Plans. Other guests represented liaison between organizations such as Swords to Plowshares, Veterans hiring and career advancement programs, including representatives of the VETERANS RESOURCE CENTER (later re-named as the VETERANS SUCCESS CENTER), Veterans Campus Clubs, Veterans Housing Programs, and the S.F. Arts Commission. We look forward to follow-up and further development of these 'mutual interest liaison contacts in the new Administration Year.

#### (b) Commissioners ATTENDANCE at General Meetings.

ATTACHED as part of this REPORT, is the official ATTENDANCE RECORD for the VAC Monthly Meetings of 2012. This document serves to meet our annual Attendance & Participation requirement. A Summary Statistics from that Report follows

- Comm. CALDERA achieved a Perfect Attendance Record for 2012 VAC meetings.
- > Comm. **WEEBY** achieved *Perfect Attendance for all meetings after appointment.*
- > As he is unable to attend Commission meetings. Comm. GRUWELL resigned from the Commission at end of '12
- > Commissioners not mentioned above, compiled an aggregate 87% attendance record.

#### Sec. 6: Heading into 2013 - the New Leadership Year

The Commission will begin the New Administration Year (2013) with completion of the traditional **Nominations and Public Elections process** as per its by-laws mandate. **Once the new Leadership Team is elected, we will work productively to address new issues and continue to make progress on all issues of concern to the Veterans Community of San Francisco.** 

Of the many issues, the over-arching, and continuing PRIMARY ISSUE regarding Future use of the War Memorial Veterans Building, remains. More specifically the Question: How Much of the War Memorial Veterans Building Can Be/Should Be Preserved for Use By and For Veterans?

We enter the New Administration Year confident that the City of San Francisco Administration (both Mayor's Office and Board of Supervisors) will join with us in a productive and inclusive process to insure a fair and equitable solution to this all-important 2013 issue.



#### CALIFORNIA DRUG ABUSE TREATMENT ACCESS REPORTING SYSTEM (DATAR)

Each certified drug/alcohol treatment provider is required to make monthly reports to the state through the Drug Abuse Treatment Access Reporting (DATAR) System at the end of every month. The summary reports give some indication of the status of treatment demand. For the month of December 2012, the DATAR summary report for San Francisco showed:

Note: Methadone slots are readily available for clients with Medi-Cal or who can afford to pay fees. The County funded low cost/no cost slots are routinely 98%+ full, but there is rarely a waiting list.

For residential and outpatient treatment, the simultaneous existence of open slots and a waiting list is due to the neighborhood locations, cultural specificity of programs, and client preferences, as well as the time delay between client notification and client registration.

Many people seek treatment after they have become homeless, and therefore face two immediate needs: housing and treatment. Many seek to fill both needs by applying for residential treatment, although housing plus outpatient treatment would work just as well. The unmet demand for low cost housing in San Francisco is so great that it is unlikely that the number of residential slots in San Francisco will ever match the demand. To address the need to maintain access to treatment for those in need, the Behavioral Health Access Center has instituted Utilization Review of residential beds/slots. There are two goals: first, to limit access to clients who need residential treatment rather than outpatient, and second, to assist clients to make a more timely transition to aftercare and housing.

The Controller's Office has issued the San Francisco Park Maintenance Standards Annual Report fiscal year (FY) 2011-12. On average, scores increased slightly from last year. The majority of parks (90 percent) continue to score above 80 percent, but more than half (80 parks) had lower scores in FY 2011-12 than in FY 2010-11. Citywide scores for different park features (e.g., lawns, children's play areas, trees, athletic fields, etc.) were consistent within three percentage points from last fiscal year, though the majority of features fell slightly. Restrooms continued to score highly, especially in comparison to initial scores in FY 2005-06.

The Controller's Office would like to thank the staff of the Recreation and Parks Department for their cooperation on the Park Maintenance Standards Program.

## Dear Supervisors:

The Sierra Club supports car share programs in general, and members of the Sierra Club are appreciative of efforts to change the overall planning and transportation context to accommodate car share programs. However, we do not believe the proposed legislation, File Number 120900, to permit increases in the allowable number of parking spaces in new developments in order to accommodate more car share spaces, will help achieve overall goals of decreasing traffic congestion and meeting greenhouse gas reductions to be in compliance with by SB 375.

Climate change concerns are urgent — oceanographer John Englander writes in his recent book, *High Tide on Main Street*, "The last truly abrupt changes in the Earth's climate occurred more than 50 million years ago. During that period, carbon dioxide levels increased by about 100 ppm over a million years. The global temperature spiked by about nine degrees F over 10,000 years. ... At our current rate of carbon emissions, we will increase carbon dioxide levels by that same 100 ppm in just 30 to 40 years." In the same book, Englander notes "... in San Francisco the statistical once-in-100-year flooding event is now a once-in-ten-year event."

In addition, the Sierra Club notes that increasing the number of allowable parking spaces – even car share spaces – violates the Transit First policy of the city, as doing so will add to overall congestion and negatively impact the flow of transit and air quality. The Sierra Club also notes that private developments, because of security issues, are not ideal places for car-share pods.

The Sierra Club encourages the Planning Commission, the Municipal Transportation Agency, and members of the Board of Supervisors to adopt best practices from elsewhere, and create dedicated accessible on-street or street-level parking for car-share vehicles, as has been done in Hoboken, New Jersey and Emeryville, California.

- are supplementing our comment with this letter. Housing and Land Use Chair 1) As far as we know, the last time the site was discussed at a Commission
  - meeting was on December 2, 2010. At that time the action item was to approve a *preliminary concept* design for community garden plots at 780 Frederick Street. As nothing beyond a preliminary concept design has been approved, why has the Recreation and Parks Department (RPD) been working on the site since early this month? Why is work continuing without further discussion or approval of the scope of work or of any final design?
  - 2) Why is there presently no community involvement in the planning process for the site? The Golden Gate Park Community Garden Committee, which was chaired by Isabel Wade with assistance from Marvin Yee of RPD met from January, 2011 through June, 2011. Now that RPD has possession of the site, shouldn't this committee continue meeting to plan and manage the community garden? Why has there been no communication with the neighbors or the local community about specific plans for the site? Why has there been no communication about the site with PROSAC or with the Kezar Advisory Committee?
  - 3) Why did RPD bulldoze a thriving community garden to build a community garden? Where are the funds for the current work coming from? Why hasn't RPD spent the funds to improve the pedestrian path in the Panhandle, which has been in dire need of repair for many years?
  - 4) Shouldn't the immediate neighbors be notified that RPD is jack hammering asphalt that covers potentially toxic soil? The site used to be a train depot and we believe there are potentially heavy metals, oil, and other toxins being released into the atmosphere. Has the soil been tested? Should there be an environmental impact report before further work continues?

- 5) The HANC Recycling Center provided recycling services for Golden Gate Park. Although new recycling containers have recently appeared in Golden Gate Park, it is not clear whether RPD has any established plan for recycling within the Park. On March 8, 2011, the Board of Supervisors adopted Resolution 121-11 which called for, among other things, that the Recreation and Parks Department and the Department of the Environment collaborate with the Haight Ashbury Neighborhood Council in developing and implementing a recycling program in Golden Gate Park. We have attached a copy of the resolution to this letter. Although HANC no longer runs a recycling center, we still have expertise in recycling and can contribute to the development and implementation of such a plan. In any event, Golden Gate Park (and other RPD facilities) should have a recycling plan.
- 6) RPD needs to work with the small business community, and especially the small businesses in the vicinity of the 780 Frederick Street site that sell beverages in recyclable containers, to ensure that the effects of the closure of the HANC recycling center are mitigated. At the very least, there needs to be a process to notify each of these businesses that they will be required to recycle any recyclable containers brought to them or they may face potential \$100 per day fines.
- 7) The HANC recycling center was closed as a non-conforming, non-recreational use of Golden Gate Park. Has RPD examined other potentially non-conforming, non-recreational uses of the Park? Does the Kezar Parking Lot fit into this category? What about the Park Police Station? Should the RPD and RPC be moved out of McLaren Lodge, so that the building can be converted into a park visitor information center and museum, or be used for other recreational purposes?

Resolution requesting the Recreation and Parks Department and the Department of the Environment collaborate to establish a comprehensive Parks recycling program utilizing the expertise, volunteer base and facilities of the HANC Recycling Center in Golden Gate Park, for the Department of the Environment to establish an Independent Recycling Center Master Plan, and requesting the Recreation and Parks Department to rescind the eviction of the HANC Recycling Center from Golden Gate Park.

WHEREAS, AB 2020, The California Recycling and Litter Reduction Act of 1986 (the "Bottle Bill") requires the City to provide residents with convenient means to redeem recyclables, a requirement not met by curbside-pick up alone; and

 WHEREAS, The Department of Environment ("DOE") has confirmed the Bottle Bill is an effective incentive that has increased diversion rates since the program was initiated; and

WHEREAS, State law requires the location of redemption centers for bottles and cans every half mile, and such centers have proven effective in reducing landfill as well as providing the capacity to recycle materials ineligible for the curbside program; and

WHEREAS, The City and County of San Francisco lacks a comprehensive, independent recycling plan which would complement the curb side recycling program and bring the City closer to its goal of zero waste by the year 2020, a component which, according to the Director of the Department of the Environment, is an "integral" part of reaching zero waste; and

WHEREAS, Of the nineteen existing independent recycling centers in San Francisco, ten reside on the east side of San Francisco in Supervisorial District Ten, disproportionately burdening the district while failing to provide equitable access for San Franciscans to independent recycling centers to properly dispose of recyclables ineligible for the curbside recycling program; and,

WHEREAS, According to the DOE's Waste Characterization study, a full 30% of the material the City sends to landfill should be recycled instead thereby demonstrating the need for independent recycling centers to augment the curbside recycling program; and

WHEREAS, The Haight Ashbury Neighborhood Council ("HANC") recycling center located in Golden Gate Park ("GGP") serves that state-mandated purpose by providing redemption for bottles and cans in addition to collecting of a vast array of recyclable materials ineligible for curbside recycling, thereby offering San Francisco residents a means to achieve their ambitious landfill diversion goals; and

WHEREAS, The Recreation and Parks Department ("RPD") recently announced a pilot recycling program for the east end of GGP centered around popular attractions and open space including the Conservatory of Flowers, Doughboy Meadow, Stow Lake and the Big Rec ball field, and

WHEREAS, According to the San Francisco Department of the Environment ("DOE") Zero Waste Coordinator, public, unmonitored recycling bins have had a low success rate meaning that improperly sorted recyclables, compostables and waste are commingled and must therefore be disposed of in landfill; and

WHEREAS, RPD provided HANC with notice that its lease for its recycling center will terminate at precisely the time when RPD could benefit from the volunteers, expertise and facilities the HANC Center provides in GGP; and

WHEREAS, The Department of the Environment's current proposal for replacing the capacity of the HANC recycling center with reverse vending machines-- which inefficiently process only one bottle or can at a time—and would require 27 machines to accommodate the volume HANC currently handles potentially creating frustratingly long lines to redeem recyclables thus contradicting the state mandate that recycling be easy and convenient: and

WHEREAS. The policy decision of installing reverse vending machines has not been analyzed in terms either the impacts on current grocery stores or merchants that would be required to implement in-store redemption or an analysis of the siting, implementation, or the street-level efficacy of the policy; and

WHEREAS. As a consequence, neither RPD nor DOE have a viable, proven alternative plan for absorbing the volume of bottles and cans and other recyclable materials collected at the HANC GGP site; and

WHEREAS, Objective One, Policy I, of the Golden Gate Park Master Plan Objectives and Policies calls upon the HANC Recycling Center "to increase its benefits to the Park" by focusing "on the recycling needs of Golden Gate Park and the immediate neighborhoods", and

WHEREAS, Golden Gate Park Master Plan Objective VI, Policy H states: "Recyclable material generated within the park should be recycled within a designated area", further stating "Volunteer programs to remove litter from the park and to increase public awareness about recycling and the impact of litter on the park should be increased"; and

WHEREAS, The HANC Recycling Center has been engaging and educating the public over the past 35 years as stewards of the built environment and continues to be a resource for recycling, taking initiative on bottle redemption, keeping the Park and

adjacent neighborhood clean and providing job opportunities and is thus ideally suited to fulfill Objective VI, Policy H of the GGP Master Plan; now, therefore, be it

RESOLVED, that the Board of Supervisors calls upon the Department of Environment to assemble a task force to create an Independent Recycling Center Master Plan that will outline the unmet recycling needs of the City and County of San Francisco which will complement the curb side pickup program and support both the intent of California's "Bottle Bill" as well as assure San Francisco's recycling programs are both sustainable, efficacious and provide a clear strategy for the City to reach its goal of zero waste by 2020; and, be it

FURTHER RESOLVED, The Board of Supervisors requests the Recreation and Parks Department and the Department of the Environment collaborate with the Haight Ashbury Neighborhood Council in developing and implementing a recycling program for Golden Gate Park; and be it

FURTHUR RESOLVED, The Board of Supervisors urges the Mayor to direct RPD to negotiate in good faith the termination of HANC's lease allowing the Recycling Center to continue to serve Golden Gate Park, continue to fulfill its mission as state-required redemption center and continue to provide the San Franciscans the capacity to recycle materials ineligible for curbside pick-up and, be it

FURTHER RESOLVED, The Board of Supervisors, in the event of the loss or downsizing of the HANC GGP site, urges the Mayor's Office, RPD and DOE to work with HANC to develop a plan to provide alternative recycling services to absorb the recycling capacity of the HANC Center, or preferably, find a suitable property to relocate the recycling services provided by HANC if RPD proceeds to evict the HANC center in such a manner as to assure the uninterrupted continuity of the center's operations and employment.
