1 [Special Election for MUD Petition]

2 CALLING AND PROVIDING FOR A SPECIAL ELECTION TO BE HELD IN THE CITY AND
3 COUNTY OF SAN FRANCISCO AND THE CITY OF BRISBANE ON TUESDAY,
4 NOVEMBER 6, 2001, FOR THE PURPOSE OF SUBMITTING TO THE VOTERS A
5 PROPOSAL TO FORM A MUNICIPAL UTILITY DISTRICT FOR THE CITY AND COUNTY
6 OF SAN FRANCISCO AND THE CITY OF BRISBANE, TO BE KNOWN AS THE "SAN
7 FRANCISCO-BRISBANE MUNICIPAL UTILITY DISTRICT"; CONSOLIDATING THE
8 SPECIAL ELECTION WITH THE GENERAL MUNICIPAL ELECTION TO BE HELD IN THE
9 CITY AND COUNTY OF SAN FRANCISCO ON NOVEMBER 6, 2001.

10 A petition for submission to the voters of a proposal for the formation of a municipal
11 utility district for the City and County of San Francisco and the City of Brisbane has been (1)
12 submitted pursuant to California Public Utilities Code sections 11611 et seq., and (2) referred
13 by the San Francisco Local Agency Formation Commission to the Board of Supervisors to call
14 an election to submit the petition to the voters.

15 NOW, THEREFORE, BE IT MOVED, That a special election is hereby called and
16 ordered to be held in the City and County of San Francisco and the City of Brisbane on
17 Tuesday, November 6, 2001, for the purpose of submitting to the voters a proposal to form a
18 municipal utility district for the City and County of San Francisco and the City of Brisbane, to
19 be known as the "San Francisco-Brisbane Municipal Utility District"; and, be it

20 FURTHER MOVED, That the special election shall be held and conducted and the
21 votes thereafter received and canvassed, and the returns thereof made and the results
22 thereof ascertained, determined and declared as herein provided and in all particulars not
23 herein recited such election shall be held according to the laws of the State of California and
24 all other applicable laws providing for and governing elections in the City and County of San

1 Francisco and the City of Brisbane, and the polls for such election shall be and remain open
2 during the time required by such laws; and, be it

3 FURTHER MOVED, That the special election hereby called shall be and hereby is
4 consolidated with the general municipal election scheduled for Tuesday, November 6, 2001,
5 in the City and County of San Francisco; and the voting precincts, polling places, voting
6 booths, and election officials in San Francisco shall in every case be the same; there shall be
7 only one set of election officers in each precinct, to wit: the election officers to be appointed by
8 the Director of Elections for each of said precincts; the candidates and measures at the
9 general municipal election shall be set forth on the ballots for said special election; all
10 proceedings had in the premises shall be recorded in one set of documents; the election shall
11 be held in all respects as though there were only one election; and, the returns of said general
12 municipal election and special election shall be canvassed by the Director of Elections, all as
13 provided in the Elections Code of the State of California and all other applicable laws, and
14 reference is hereby made to the notice of election setting forth the voting precincts, polling
15 places and officers of election for the November 6, 2000 general municipal election to be
16 published by the Director of Elections in the official newspapers of the City and County on the
17 date required under the laws of the State of California; and, be it

18 FURTHER MOVED, That the Board of Supervisors of the City and County of San
19 Francisco urges the City Council of the City of Brisbane to consolidate said election with the
20 general election to be held in Brisbane on Tuesday, November 6, 2001.


