2 **Motion amending the Agreement for Professional Budget Analyst Services between the**
3 **City and County of San Francisco and Stanton W. Jones and Associates/Debra A.**

7 **service for Fiscal Year 2000-2001 by \$218,208.**

9 WHEREAS, The Board of Supervisors requests its Budget Analyst Office to increase
10 its level of support in the amount of \$218,208, to provide additional resources as follows: 1)
11 To analyze the proposed Fiscal Year 2001-2002 Budget prior to June 1, 2001 with focus on
12 specific departments; 2) To perform a zero base budget review of the Fire Department; 3) To
13 conduct periodic meetings with members of the Board of Supervisors for the purpose of
14 reviewing their budget priorities and reviewing major departmental policies; and 4) To
15 increase performance audit resources of the Budget Analyst Office, as assigned; and

16 WHEREAS, Section 5 of the existing agreement allows for the Board, by motion, to
17 authorize the Budget Analyst to provide specific work on performance audits and special
18 projects under the process; and

19 WHEREAS, The Board of Supervisors has approved an appropriation of \$218,208 of
20 the General Reserve Fund to fund the increase of services provided by the Board of
21 Supervisor’s Budget Analyst for FY 2000-2001; now, therefore, be it

22 MOVED, That the Board of Supervisors hereby amends its agreement with the Budget
23 Analyst Joint Venture to provide that the Budget Analyst shall increase the level of service to
24 provide the services aforementioned;

1 FURTHER, BE IT MOVED, That the Clerk of the Board of Supervisors is authorized
2 and directed to take all necessary administrative steps to carry out the intent of this motion.


