WHEREAS, The term homeless includes individuals or families who lack a fixed, regular, and adequate nighttime residence and who have a primary residence in one or more of the categories outlined in the San Francisco Local Homeless Coordinating Board's Definition of Homelessness, on file with the Clerk of the Board of Supervisors in File No. 011840 which is hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it
