13 WHEREAS, the Board of Supervisors of the City and County of San Francisco wishes
14 to extend for two years, with three additional two-year options (to be exercised at the
15 discretion of the Board of Supervisors), the existing Joint Venture Agreement to provided
16 Budget Analyst services; now, therefore, be it

17 MOVED, That the Board of Supervisors hereby amends its Agreement with the Budget
18 Analyst Joint Venture to extend it by two years through December 31, 2005, with two options
19 for an additional period of two years each (to be exercised by the Board of Supervisors), for a
20 total possible extension of six years, through December 31, 2001, at an annual cost of
21 \$2,090,339, as may be adjusted annually based on the average annual percentage change in
22 total compensation granted to miscellaneous employees of the City performing similar work;
23 and, be it

24 FURTHER MOVED, That the Clerk of the Board of Supervisors is authorized and
25 directed to take all administrative steps necessary to carry out the intent of this motion.


