

1 [Directing the Budget Analyst to conduct a management audit of the San Francisco
2 International Airport – Airfield Development Bureau on a priority basis]

3 **Motion amending the Schedule of Audits for the Budget Analyst and directing the**
4 **Budget Analyst to conduct a management audit of the San Francisco International**
5 **Airport’s Airfield Development Bureau and to perform this management audit as the**
6 **next priority assignment.**

8 WHEREAS, the San Francisco International Airport (SFO) has spent approximately
9 \$70 million on its Airfield Development Bureau, which coordinates the Airport’s Runway
10 Modernization Project; and

11 WHEREAS, in June, 2002, SFO requested that the Board of Supervisors appropriate
12 \$11.2 million of additional funds to the Airfield Development Bureau; and

13 WHEREAS, the Board of Supervisors appropriated \$6.2 million of these requested
14 funds and placed \$5 million of these funds on reserve, citing media reports and public
15 concerns about questionable spending by SFO’s Airfield Development Bureau; and

16 WHEREAS, SFO leaders report that they anticipate returning to the Board of
17 Supervisors in the future to request appropriation for at least some of the funds currently on
18 reserve; and

19 WHEREAS, a focused audit of SFO’s Airfield Development Bureau will provide the
20 Board of Supervisors necessary information as it considers future appropriations to the Airfield
21 Development Bureau and ensure that current and past spending at the Airfield Development
22 is appropriate; now

1 THEREFORE BE IT MOVED, that the Board of Supervisors assigns the Budget
2 Analyst to conduct a management audit of the San Francisco International Airport's Airfield
3 Development Bureau; and, be it

4 FURTHER MOVED, That the Board of Supervisors hereby amends the Schedule of
5 Management Audits and directs the Budget Analyst to conduct a management audit of the
6 Airfield Development Bureau on a priority basis as the next management audit assignment.
