9 adding section 4.117 to establish the composition of and appointment of members to the  
10 San Francisco Entertainment Commission. , (File 020805); and, be it

11 FURTHER MOVED, That the full text of said argument hereby authorized be shown  
12 in the copy attached to this motion and is hereby declared to be a part hereof; and, be it

13 FURTHER MOVED, That the Director of Elections be and is hereby authorized and  
14 directed to include said argument in the pamphlet accompanying the sample ballots to be  
15 mailed to the voters of the City and County of San Francisco for the election to be held on  
16 Tuesday, November 5, 2002.
