7 WHEREAS, San Francisco Charter section 13.104.5 prohibits City employees and
8 officers (other than the Director of Elections, an appointee of the Director of Elections or a
9 member of the Elections Commission) from performing "any function relating to the conduct of
10 an election;" and,

11 WHEREAS, Charter section 13.104.5 authorizes the Board of Supervisors, upon the
12 request of the Elections Commission, to waive this prohibition for election day activity; and,

13 WHEREAS, The Elections Commission has requested that the Board of Supervisors
14 waive this prohibition to permit City employees to ~~serve as Field Election Deputies and~~
15 ~~otherwise~~ assist the Department of Elections on election day, ~~November 5, 2002~~; now,
16 therefore, be it

17 MOVED, That the Board of Supervisors waives the prohibition imposed by Charter
18 section 13.104.5, to permit ~~employees of the Controller's Office and the City Attorney's Office~~
19 ~~and~~ civil servants working for City departments, other than departments whose elective officer
20 is standing for election on November 5, 2002 or December 10, 2002, to serve as Field
21 Election Deputies and to permit such civil servants and employees of the City Attorney's office
22 to otherwise assist the Department of Elections on November 5, 2002 and December 10,


