12 WHEREAS, The 1996 Charter Section 2.103 continued to allow meetings of the San  
13 Francisco Board of Supervisors committees to be held outside of City Hall; and

14 WHEREAS, The Board of Supervisors on February 4, 2003 approved a Motion  
15 establishing a joint City and School District Select Committee to hear measures concerning  
16 issues of mutual interest that affect the City and School District, its employees, its students,  
17 and the families of its students, including the issue of the public use of the School District  
18 facilities, and this Committee shall terminate one year from the date of the appointment of  
19 its members; now therefore be it

20 MOVED, That the Board of Supervisors of the City and County of San Francisco  
21 does hereby order that the April 14, June 9, August 11, October 20, and December 8, 2003,  
22 meetings of the City and School District Select Committee be held at the Irving G. Breyer  
23 Board Meeting Room, Board of Education, 555 Franklin Street, First Floor, San Francisco at


