13 WHEREAS, The Board of Supervisors on February 4, 2003 approved a Motion  
14 establishing a joint City and School District Select Committee to hear measures concerning  
15 issues of mutual interest that affect the City and School District, its employees, its students,  
16 and the families of its students, including the issue of the public use of the School District  
17 facilities, and this Committee shall terminate one year from the date of the appointment of  
18 its members; now therefore be it

20 **does hereby order that the June 16, 2003 meeting of the City and School District Select**  
21 **Committee be held at the Irving G. Breyer Board Meeting Room, Board of Education, 555**


