4 **Motion granting a waiver from the prohibition imposed by Charter section 13.104.5, to**
5 **permit City employees to assist the Department of Elections with the October 7, 2003,**
6 **November 4, 2003, December 9, 2003 and March 2, 2004 elections.**

8 WHEREAS, San Francisco Charter section 13.104.5 prohibits City employees and
9 officers (other than the Director of Elections, an appointee of the Director of Elections or a
10 member of the Elections Commission) from performing "any function relating to the conduct of
11 an election;" and,

12 WHEREAS, Charter section 13.104.5 authorizes the Board of Supervisors, upon the
13 request of the Elections Commission, to waive this prohibition; and,

14 WHEREAS, The Elections Commission may request that the Board of Supervisors
15 waive this prohibition to permit City employees to assist the Department of Elections with the
16 October 7, 2003, November 4, 2003, and March 2, 2004 elections; and

17 WHEREAS, The Elections Commission may request that the Board of Supervisors
18 waive this prohibition to permit City employees to assist the Department of Elections with an
19 election that may occur on December 9, 2003; now, therefore, be it

20 MOVED, If Clerk of the Board of Supervisors receives such requests from the Elections
21 Commission, the Board of Supervisors waives the prohibition imposed by Charter section
22 13.104.5, to permit City employees to assist the Department of Elections before, during and
23 after the October 7, 2003, November 4, 2003, and March 2, 2004 elections as well as any
24 election that might occur on December 9, 2003.
