11 written proponent or opponent argument and rebuttal argument for or against any ballot  
12 measure for publication in the voters information pamphlet, consistent with other provisions of  
13 the Municipal Elections Code; and

15 WHEREAS, The Board of Supervisors has submitted several Charter Amendments  
16 and other Measures to the voters at the March 2, 2004 Election in the City and County of San  
17 Francisco; and

18 WHEREAS, The Board of Supervisors wishes to authorize the sponsors of the
