15 ~~regular meeting in the Chamber in City Hall each week at 2:00 p.m. on Monday, unless it is a holiday,~~  
16 ~~in which case the meeting shall be held on the next regular business day. Effective the week of~~  
17 ~~February 2, 2003, the~~ The Board shall hold a regular meeting in the Chamber in City Hall each  
18 week at 2:00 p.m. on Tuesday, unless it is a holiday, in which case the meeting shall be  
19 ~~cancelled~~ held on the next regular business day. The Board shall not meet during the week after  
20 Thanksgiving, or between December 24 and December 31, inclusive, ~~, nor on any Monday or~~  
21 ~~Tuesday if the following day is a holiday, unless the Board, by majority vote, decides to hold a meeting~~  
22 ~~at these times. Neither the Board of Supervisors nor any of its Committees shall convene regularly~~  
23 ~~scheduled meetings during weeks when a holiday occurs, effective beginning the week of May 26, 2003,~~  
24 ~~except that regularly scheduled Board and Committee meetings may be held on Monday through~~  
25 ~~Wednesday of Thanksgiving week, and shall not be scheduled during the week following Thanksgiving.~~  
~~In addition, neither the Board nor any of its committees shall convene regularly scheduled meetings~~

1 *during the week of the first Tuesday of March, June and August. Further, neither the Board nor any of*  
2 *its Committees shall convene regularly scheduled meetings during the week of the first Tuesday of*  
3 *April, in honor of the birthday (March 31) of Cesar Chavez.*
