

1 [Extending Time for Labor Negotiations to June 30, 2005]

3 **Motion extending time for labor negotiations to June 30, 2005, pursuant to Charter**  
4 **Section 11.100.**

6 WHEREAS, The City and most of its labor unions have existing collective bargaining  
7 agreements that are effective through June 30, 2005;

8 WHEREAS, The City has and will be meeting and conferring with labor organizations  
9 over successor collective bargaining agreements for fiscal year 2005-2006 in accordance with  
10 Charter Section A8.409; and

11 WHEREAS, In order to be included in the budget to take effect July 1, 2005 an  
12 agreement or arbitration award must be approved and implemented by ordinance within the  
13 timelines set forth in Charter Section A8.409-4, as may be extended by Charter Section  
14 11.100; and

15 WHEREAS, The Board of Supervisors previously clarified such deadlines in Resolution  
16 No. 91-97; and

17 WHEREAS, Under Charter Section A8.409-4 the Human Resources Director has  
18 requested that the Board of Supervisors take action pursuant to Charter Section 11.100 to  
19 extend by thirty days the date for final adoption of ordinances approving and implementing  
20 successor collective bargaining agreements; now therefore, be it

21 MOVED, That the date for final adoption of ordinances approving and implementing  
22 successor collective bargaining agreements to be effective July 1, 2005 is hereby extended by  
23 thirty days. For unions and unrepresented employees in negotiations for which impasse has  
24 not been declared, the date for final adoption of ordinances approving and implementing  
25 successor collective bargaining agreements to be effective July 1, 2005 is April 26, 2005.

5 pursuant to Charter Section A8.409-4 should be submitted to the Clerk of the Board in a form  
6 that will allow for complete review and costing in time for final adoption by June 30, 2005.
