WHEREAS, On March 29, 2005, the Board of Supervisors adopted Ordinance No. 64-05, an urgency Ordinance that imposed a 45-day moratorium on clubs or dispensaries where marijuana is grown, purchased or distributed with a medical recommendation. A copy of said Ordinance is on file with the Clerk of the Board of Supervisors in File No. 050512, and is incorporated herein by reference; and,

WHEREAS, On April 1, 2005, the Mayor signed Ordinance No. 64-05 into law; and

WHEREAS, Said Ordinance was adopted in accordance with California Government Code section 65858, which governs the adoption and extension of interim zoning moratoria; and,

WHEREAS, Government Code section 65858(d) requires the local legislative body to issue a written report describing the measures taken to alleviate the condition that led to the adoption of the moratorium; and,

WHEREAS, On April 25~~2~~, 2005, the Planning Department issued a report entitled "Report on Status and Regulatory Actions Regarding Medical Cannabis Dispensaries"-Interim ~~Ordinance on Clubs or Dispensaries Where Marijuana Is Grown, Purchased or Distributed With a Medical Recommendation-~~ for the Board's consideration. A copy of said report is on file with the Clerk of the Board of Supervisors in File No. 050512 and is incorporated herein by reference; and
