

1 [Preparation of findings related to the categorical exemption issued for 899 North Point  
2 Street.]

3 **Motion directing the Clerk of the Board to prepare findings related to the appeal of the**  
4 **determination by the Planning Department that the 899 North Point Street project is**  
5 **categorically exempt from environmental review under the California Environmental**  
6 **Quality Act.**

8 WHEREAS, the Environmental Review Office of the San Francisco Planning  
9 Department issued a certificate of determination of exemption/exclusion from environmental  
10 review for the demolition of a vacant gas station and construction of a 5-unit residential  
11 building at 899 North Point Street ("Project") on April 22, 2005 (the "determination"). A copy of  
12 said document is on file with the Clerk of the Board of Supervisors in File No. 051222, and is  
13 incorporated by reference herein; and,

14 WHEREAS, By letter to the Clerk of the Board of Supervisors dated June 17, 2005,  
15 Stephen M. Williams filed an appeal of the determination to the Board of Supervisors, which  
16 the Clerk of the Board of Supervisors received on or around June 17, 2005; and,

17 WHEREAS, On July 26, 2005, this Board held a duly noticed public hearing to consider  
18 the appeal of the determination. Following the conclusion of the public hearing, the Board  
19 rendered a decision on the use of the exemption/exclusion for the Project based on the written  
20 record before the Board in File No. 051222 which is hereby declared to be a part of this  
21 motion as if set forth fully herein, as well as all of the testimony at the public hearing in support  
22 of and opposed to the appeal; and,

23 WHEREAS, In regard to said decision, this Board made certain findings specifying the  
24 basis for its decision; now, therefore, be it


