11 Board of Supervisors in File No. 051780 and is incorporated herein by reference; and,

12 WHEREAS, The Department of Public Works, in a decision dated October 20, 2005,  
13 approved a Tentative Parcel Map to subdivide an existing lot into two legal lots of record at  
14 554 Valley Street, Lot 081 in Assessor's Block No. 6611. Said determination is on file with the  
15 Clerk of the Board of Supervisors in File No. 051780 and is incorporated herein by reference;  
16 now, therefore, be it

17 MOVED, That the Board hereby adopts as its own the Planning Department's  
18 environmental findings and findings of consistency with the General Plan and Planning Code  
19 Section 101.1; and, be it

20 FURTHER MOVED, That the Board approves the decision of the Department of Public  
21 Works concerning the Tentative Parcel Map and hereby approves said Map.


