3 **Motion affirming the determination by the Planning Department that the 899 North Point**  
4 **Street project is categorically exempt from environmental review under the California**  
5 **Environmental Quality Act.**

7 WHEREAS, the Environmental Review Office of the San Francisco Planning  
8 Department issued a certificate of determination of exemption/exclusion from environmental  
9 review for the demolition of a vacant gas station and construction of a 5-unit residential  
10 building at 899 North Point Street ("Project") on April 22, 2005 (the "determination"). A copy of  
11 said document is on file with the Clerk of the Board of Supervisors in File No. 051222, and is  
12 incorporated by reference herein; and,

13 WHEREAS, By letter to the Clerk of the Board of Supervisors dated June 17, 2005,  
14 Stephen M. Williams filed an appeal of the determination to the Board of Supervisors, which  
15 the Clerk of the Board of Supervisors received on or around June 17, 2005; and,

16 WHEREAS, On July 26, 2005, this Board held a duly noticed public hearing to consider  
17 the appeal of the determination; and,

18 WHEREAS, This Board has reviewed and considered the determination, the appeal  
19 letter, the responses to concerns document that the Planning Department prepared, and  
20 public testimony; and,

21 WHEREAS, The determination files and all correspondence and other documents have  
22 been made available for review by this Board and the public. These files are available for  
23 public review by appointment at the Planning Department offices at 1660 Mission Street, and  
24 are part of the record before this Board by reference herein; now, therefore, be it


