

1 [Preparation of findings related to the CEQA exemption determination issued for a proposed  
2 ordinance regulating off-street parking in C-3 zoning districts.]

3 **Motion directing the Clerk of the Board to prepare findings related to the appeal of the**  
4 **determination by the Planning Department that a proposed ordinance regulating off-**  
5 **street parking in C-3 zoning districts is exempt from environmental review under the**  
6 **California Environmental Quality Act.**

8 WHEREAS, The Environmental Review Office of the San Francisco Planning  
9 Department issued a determination of exemption/exclusion from environmental review for an  
10 ordinance regulating off-street parking in C-3 Zoning Districts on September 23, 2005 (the  
11 "determination). A copy of said document is on file with the Clerk of the Board of Supervisors  
12 in File No. 051996, and is incorporated by reference herein; and,

14 WHEREAS, By letter to the Clerk of the Board of Supervisors dated December 5, 2005,  
15 Wade Randlett on behalf of SFSOS filed an appeal of the determination to the Board of  
16 Supervisors, which the Clerk of the Board of Supervisors received on or around December 5,  
17 2005; and,

18  
19 WHEREAS, On January 10, 2006, this Board held a duly noticed public hearing to  
20 consider the appeal of the determination. Following the conclusion of the public hearing, the  
21 Board rendered a decision on the use of the exemption/exclusion for the project based on the  
22 written record before the Board in File No. 051996 which is hereby declared to be a part of  
23 this motion as if set forth fully herein, as well as all of the testimony at the public hearing in  
24 support of and opposed to the appeal; and,

25  
WHEREAS, In regard to said decision, this Board made certain findings specifying the  
basis for its decision; now, therefore, be it

1 Moved, That this Board of Supervisors directs the Clerk of the Board to prepare the  
2 findings specifying the basis for its decision on the use of the exemption/exclusion for the  
3 proposed ordinance regulating off-street parking in C-3 zoning districts.
