3 **Motion affirming the determination by the Planning Department that the 229 32<sup>nd</sup>**  
4 **Avenue (aka 7070 California Street) project is categorically exempt from environmental**  
5 **review under the California Environmental Quality Act.**

8 WHEREAS, On October 31, 2005, the Environmental Review Office of the San  
9 Francisco Planning department issued a certificate of determination of exemption/exclusion  
10 from environmental review (the "determination") for proposed construction of a two-story,  
11 26.5-foot tall arts and science building containing six classrooms and removal of a paved  
12 tennis court, located at the Katherine Delmar Burke School at 229 32<sup>nd</sup> Avenue (aka 7070  
13 California Street) (the "Project"). A copy of said document is on file with the Clerk of the  
14 Board of Supervisors in File No. 060980, and is incorporated by reference herein; and,

15 WHEREAS, By letter to the Clerk of the Board of Supervisors dated June 20, 2006,  
16 James Argo, on behalf of the Lincoln Park Neighborhood Association ("Appellant"), filed an  
17 appeal of the determination to the Board of Supervisors, which the Clerk of the Board of  
18 Supervisors received on or around June 20, 2006; and,

19 WHEREAS, On July 25, 2006, this Board held a duly noticed public hearing to consider  
20 the appeal of the determination; and,

21 WHEREAS, This Board has reviewed and considered the determination, the appeal  
22 letter, the responses to concerns document that the Planning Department prepared, and  
23 public testimony; and,

24 WHEREAS, The determination files and all correspondence and other documents have  
25 been made available for review by this Board and the public. These files are available for
