16 Planning Department, by its letter dated November 8, 2006, that the proposed subdivision  
17 is consistent with the objectives and policies of the General Plan and the Eight Priority Policies  
18 of Section 101.1 of the Planning Code; and be it

19           FURTHER MOVED, That the San Francisco Board of Supervisors hereby authorizes  
20 the Director of the Department of Public Works to enter all necessary recording information  
21 on the Final Map and authorizes the Clerk of the Board of Supervisors to execute the Clerk's  
22 Statement as set forth herein; and be it

23           FURTHER MOVED, That approval of this map is also conditioned upon compliance  
24 by the subdivider with all applicable provisions of the San Francisco Subdivision Code  
25 and amendments thereto.
