3 **Motion disapproving the decision of the decision of the Planning Commission**  
4 **disapproving proposed landmark designation of 55 Laguna Street.**

6 WHEREAS, on April 18, 2007, the Landmarks Preservation Advisory Board  
7 (Landmarks Board) voted on and passed Resolution #613, "Adopting Findings Related to the  
8 Recommendation of Approval of the Landmark Designation of the U.C. Extension Center at  
9 55 Laguna (formerly San Francisco State Teacher's College) as a San Francisco Landmark  
10 Under Article 10 of the Planning Code" and forwarded the resolution to the Planning  
11 Commission for their review; and

12 WHEREAS, On May 24, 2007, the Planning Commission considered the proposed  
13 landmark designation at a duly noticed public hearing and passed Planning Commission  
14 Resolution #17445 recommending disapproval of the proposed landmark designation of 55  
15 Laguna Street, the U.C. Extension Center; and

16 WHEREAS, By letters to the Clerk of the Board dated July 12 and July 13, respectively,  
17 The Landmarks Preservation Advisory Board and the San Francisco Preservation Consortium  
18 appealed the determination of the Planning Commission recommending disapproval of a  
19 landmark designation of U.C. Extension Center, located at 55 Laguna Street; and

20 WHEREAS, This Board held a duly noticed public hearing to consider the appeal of the  
21 determination; and

22 WHEREAS, This Board has reviewed and considered the determination, the appeal  
23 letter, all documents submitted in support of and opposed to the Planning Commission's  
24 determination, and public testimony; now, therefore, be it

1            MOVED, That this Board of Supervisors disapproves the determination by the Planning  
2 Commission that the U.C. Extension Center located at 55 Laguna should not be designated  
3 as a San Francisco landmark.
