3 **Motion appointing Diana Jenson, term ending March 15, 2009, to the Food Security**
4 **Task Force, residency requirement waived.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated persons to serve as members of the Food Security
8 Task Force, pursuant to the provisions of Ordinance No. 206-05, for the term specified:

9 Diana Jensen (residency requirement waived), seat 5, must be from the Department of
10 Aging and Adult Services of the Human Services Agency, for term ending March 15, 2009;
11 and, be it

12 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 13 1. The membership of the Food Security Task Force has a goal to be representative of
14 the diversity of the City and County of San Francisco.
- 15 2. Applicant Diana Jenson, who is not a resident of San Francisco, are persons with
16 experience that uniquely qualifies them to serve on the Food Security Task Force.
- 17 3. The Food Security Task Force has attempted to fill the position, for which Diana
18 Jenson were nominated, with an individual who is a City resident and who have the
19 specific experience, skills, and qualifications, but has been unable to do so at this
20 time. The Rules Committee has certified that Diana Jensen qualified to serve on
21 the Food Security Task Force.
- 22 4. After exercising due diligence, the Board of Supervisors concludes that there is no
23 other possible representative, who are residents of San Francisco and who have
24 the specific experience, skills, or qualifications possessed by this applicant, and
25 who are willing to serve on the Food Security Task Force at this time; and, be it

1 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
2 for Diana Jensen, as allowed in cases where no qualified City resident, willing to serve, can
3 be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to
4 boards, commissions, and advisory bodies established by legislative act of the Board of
5 Supervisors to be resident(s) of the City and County of San Francisco.
