4 **Motion directing the Clerk of the Board to prepare findings related to the appeal of the**  
5 **determination by the Planning Department that the project at 800-808 Lyon Street/1980-**  
6 **1988 Golden Gate Avenue is exempt from environmental review under the California**  
7 **Environmental Quality Act.**

9 WHEREAS, On September 2, 2008, the Planning Department issued a memorandum  
10 stating that it had determined (the "determination") that the project located at 800-808 Lyon  
11 Street/1980-1988 Golden Gate Avenue (the "Project") was categorically exempt from  
12 environmental review under the California Environmental Quality Act ("CEQA"). A copy of  
13 said document is on file with the Clerk of the Board of Supervisors in File No. 081171, and is  
14 incorporated by reference herein; and,

15 WHEREAS, On September 3, 2008, Raquel Fox, on behalf of the Tenderloin Housing  
16 Clinic, Inc. ("Appellant") filed an appeal dated September 3, 2008, with the Clerk of the Board  
17 of Supervisors of the determination by the Planning Department; and,

18 WHEREAS, On October 7, 2008, this Board held a duly noticed public hearing to  
19 consider the appeal of the determination. Following the conclusion of the public hearing, the  
20 Board rendered a decision on the use of the exemption/exclusion for the project based on the  
21 written record before the Board in File No. 081171 which is hereby declared to be a part of  
22 this motion as if set forth fully herein, as well as all of the testimony at the public hearing in  
23 support of and opposed to the appeal; and,

24 WHEREAS, In regard to said decision, this Board made certain findings specifying the  
25 basis for its decision; now, therefore, be it

1 Moved, That this Board of Supervisors directs the Clerk of the Board to prepare the  
2 findings specifying the basis for its decision on the use of the exemption/exclusion for the  
3 Project.
