15 WHEREAS, Similar to other sitting legislative bodies in the United States, the Board
16 has established recess periods during the summer and winter which members of the Board
17 may plan to be away, without missing any Board or Committee meetings or other important
18 public business, and without causing difficulties in achieving a quorum; now, therefore, be it

19 RESOLVED, Pursuant to Section 6.2 of the Rules of Order, the 2009 regular meetings
20 to be canceled are: January 20, (Martin Luther King Jr. day); February 17, (Presidents day);
21 May 26, (Memorial day); September 8, (Labor day); September 29, (Yom Kippur); October 13,
22 (Columbus day); December 1, (Week after Thanksgiving); and, be it

23 FURTHER RESOLVED, That pursuant to the established tradition of summer and
24 winter recess periods, the Board and Committee meetings scheduled from August 19 through
25 September 8, 2009, and December 16 through December 31, 2009 are canceled.
