

1 [Concurring in Declaration of Emergency.]

3 **Motion concurring in the April 30, 2009 Declaration of Local Emergency by the Mayor,**  
4 **and in the Actions the Declaration of Emergency Authorizes the City and its Officers**  
5 **and Employees to Take to Meet the Emergency.**

7 WHEREAS, On April 30, 2009 Mayor Gavin Newsom declared a local emergency in  
8 connection with the presence in the City and County of San Francisco of the 2009 influenza  
9 type A, subtype H1N1 flu, which was then first confirmed in the City; and

10 WHEREAS, The Mayor has transmitted a copy of that emergency declaration to the  
11 Board of Supervisors, and such copy is located in Board file No. 090545; and

12 WHEREAS, Government Code Sections 8550 et seq. and Charter Section 3.100  
13 provide for the concurrence of the Board of Supervisors in such emergency declaration and in  
14 the action the Mayor has taken and ordered to be taken to meet the emergency; and,

15 WHEREAS, The Mayor's Declaration of Emergency orders that:

16 "(1) All City officers and employees take all steps recommended  
17 by the Director of Public Health to prevent the spread of the 2009  
18 H1N1 Flu and to prevent or alleviate illness or death due to the  
19 virus; and

20 (2) All City officers and employees take all steps recommended by  
21 the Director of Public Health to qualify the City for reimbursement  
22 from the Federal Emergency Management Agency and for such  
23 other state and federal relief as may be available to reimburse the  
24 City for the expenses it incurs in addressing this emergency"; and
