

1 [Appointment - Sunshine Ordinance Task Force]

3 **Motion appointing Suzanne Manneh, term ending April 27, 2011, to the Sunshine**  
4 **Ordinance Task Force, residency requirement waived.**

5  
6 MOVED, That the Board of Supervisors of the City and County of San Francisco does  
7 hereby appoint the hereinafter designated person to serve as a member of the Sunshine  
8 Ordinance Task Force, pursuant to the provisions of the San Francisco Administrative Code,  
9 Section 67.30, for the term specified:

10 Suzanne Manneh, seat 4, succeeding Ketaki Gokhale, resigned, must be appointed  
11 from names submitted by New California Media and be a journalist from a racial/ethnic-  
12 minority-owned news organization, for the unexpired portion of a two-year term ending  
13 April 27, 2011, residency requirement waived.

14 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 15 1. The membership of the Sunshine Ordinance Task Force has a goal to be  
16 representative of the diversity of the City and County of San Francisco.
- 17 2. Applicant Suzanne Manneh, a new appointee, who is not a resident of San  
18 Francisco, is a person with experience that uniquely qualifies her to serve on the  
19 Sunshine Ordinance Task Force.
- 20 3. The Sunshine Ordinance Task Force has attempted to fill the position, for which  
21 Suzanne Manneh was nominated, with an individual who is a City resident and who  
22 has the specific experience, skills, and qualifications, but has been unable to do so  
23 at this time. The Rules Committee has certified that Suzanne Manneh is qualified  
24 to serve on the Sunshine Ordinance Task Force.

1 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
2 other possible representative, who is a resident of San Francisco and who has the  
3 specific experience, skills, or qualifications possessed by this applicant, and who is  
4 willing to serve on the Sunshine Ordinance Task Force at this time; and, be it

5 FURTHER MOVED, That the Board of Supervisors waives the residency requirement  
6 for Suzanne Manneh, as allowed in cases where no qualified City resident, willing to serve,  
7 can be found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed  
8 to boards, commissions, and advisory bodies established by legislative act of the Board of  
9 Supervisors to be resident(s) of the City and County of San Francisco.
