15 MOVED, That the Board of Supervisors authorizes and directs the Clerk of the Board  
16 of Supervisors to commence negotiations with Harvey M. Rose Associates, LLC, Debra A.  
17 Newman, Louie and Wong, LLP, A Joint Venture for Budget and Legislative Analyst Services  
18 per RFP #BOS-01-424, and, if those negotiations do not produce an agreement, to  
19 commence negotiations with the next-highest bidder under the RFP.
