4 **Motion authorizing preparation of written Proponent and Opponent ballot arguments**
5 **and rebuttal ballot arguments for submittal to the voters at the June 8, 2010, Election.**

7 WHEREAS, The Board of Supervisors wishes to authorize the Board Member
8 sponsors of the following ballot measures to prepare and submit a written proponent ballot
9 argument and proponent rebuttal argument for submittal to the Director of Elections:

11 • Charter Amendment to amend by amending Sections A8.432, A8.506, A8.506-2,
12 A8.506-3, and A8.510, and by adding Sections A8.432-1, A8.600 to A8.600-14, A8.601
13 to A8.601-16 and A8.602 to A8.602-16, to: (1) define "Participating Employers" for the
14 Retiree Health Care Trust Fund to include the Superior Court of California, City and
15 County of San Francisco, to the extent it participates in the City and County's Health
16 Service System and upon resolution by its governing board; (2) require the difference
17 between the City and County's contribution to the San Francisco Employees'
18 Retirement System (SFERS) set by the Retirement Board each year and the employer
19 normal cost rate to be deposited into the Retiree Health Care Trust Fund; (3) require
20 the difference between the "Participating Employers" contribution to SFERS set by the
21 Retirement Board each year and the employer normal cost rate to be deposited into the
22 Retiree Health Care Trust Fund only upon resolution by the governing boards of the
23 respective "Participating Employers" approving said deposits; (4) establish an
24 employee contribution rate of nine percent for all employees hired on and after July 1,
25 2010, who become members of the California Public Employees' Retirement System

1 (CalPERS); (5) require all contracts with CalPERS for persons hired on and after July
2 1, 2010, to include a two-year formula for the calculation of final compensation to the
3 fullest extent possible; (6) require all contracts and contract amendments on and after
4 July 1, 2010, for personnel of the sheriff's department and housing authority police who
5 are members of CalPERS to be cost-neutral to the City and County; (7) create a new
6 retirement plan for miscellaneous officers and employees hired on and after July 1,
7 2010, that modifies the average final compensation calculation from a one-year formula
8 to a two-year formula; and (8) create new retirement plans for safety members hired on
9 and after July 1, 2010, that increase required employee retirement contributions to nine
10 percent and modify the average final compensation calculation from a one-year formula
11 to a two-year formula. (Supervisors Mar, Campos, Elsbernd)

21 retrofitting of Neighborhood Fire and Police Stations, the Auxiliary Water Supply
22 System, a Public Safety Building, and other critical infrastructure and facilities for

12 proposed bond is in conformity with the priority policies of Planning Code Section
13 101.1(b) and with the General Plan consistency requirement of Charter Section 4.105
14 and Administrative Code Section 2A.53; consolidating the special election with the
15 general election; establishing the election precincts, voting places and officers for the
16 election; waiving the word limitation on ballot propositions imposed by San Francisco
17 Municipal Elections Code Section 510; complying with the restrictions on the use of
18 bond proceeds specified in Section 53410 of the California Government Code;
19 incorporating the provisions of the San Francisco Administrative Code, Sections 5.30 -
20 5.36; and waiving the time requirements specified in Section 2.34 of the San Francisco

22 deadline of noon, March 18, 2010, and the respective rebuttal ballot argument no later than
23 noon, March 22, 2010; now, therefore, be it

24 MOVED, That the Board of Supervisors hereby authorizes the sponsors and
25 designated opponents of each measure, as listed above, under the provisions of the San

1 Francisco Elections Code Sections 530 and 550, to prepare and submit a written proponent
2 and opponent ballot argument and respective rebuttal ballot arguments on their measures;
3 and, be it

4 FURTHER MOVED, That the sponsors and opponents of measures submitted to the
5 voters for the June 8, 2010, Election, who are authorized by this motion to prepare and submit
6 arguments, may authorize or assign to any other person(s) under the provisions of the San
7 Francisco Elections Code Sections 530 and 550 (c) and (d) the right to prepare and submit
8 the proponent or opponent's ballot arguments and/or respective rebuttal arguments.
