

1 [Appointments – SOMA Community Stabilization Fund Community Advisory Committee]

3 **Motion appointing Conny Ford, Ada Chan, Allan Manalo, Judith Baker, and Thomas**
4 **Temprano, terms ending April 27, 2011 and April 27, 2012, to the SOMA Community**
5 **Stabilization Fund Community Advisory Committee, residency requirement waived.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby appoint the hereinafter designated persons to serve as members of the SOMA
8 Community Stabilization Fund Community Advisory Committee, pursuant to the provisions of
9 Planning Code Section 318 and Ordinance No. 217-05, for the terms specified:

10 Conny Ford, seat 2, succeeding herself, term expired, must have expertise in
11 employment development and/or represents labor, for the unexpired portion of a two-year
12 term ending April 27, 2012.

13 Ada Chan (residency requirement waived,) seat 4, succeeding herself, term expired,
14 must have affordable housing expertise and familiarity with the SOMA neighborhood, for the
15 unexpired portion of a two-year term ending April 27, 2011.

16 Allan Manalo, seat 5, succeeding Angelica Cabande, term expired, must represent a
17 community-based organization in SOMA, for the unexpired portion of a two-year term ending
18 April 27, 2011.

19 Judith Baker, seat 6, succeeding herself, term expired, must provide direct services to
20 SOMA families, for the unexpired portion of a two-year term ending April 27, 2012.

21 Thomas Temprano, seat 7, succeeding Steven Sarver, term expired, must have small
22 business expertise and a familiarity with the SOMA neighborhood, for the unexpired portion of
23 a two-year term ending April 27, 2012.

24 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1 1. The membership of the SOMA Community Stabilization Fund Community Advisory
2 Committee has a goal to be representative of the diversity of the City and County of
3 San Francisco.
- 4 2. Applicant Ada Chan, an incumbent, who is not a resident of San Francisco, is a
5 person with experience that uniquely qualifies her to serve on the SOMA
6 Community Stabilization Fund Community Advisory Committee.
- 7 3. The SOMA Community Stabilization Fund Community Advisory Committee has
8 attempted to fill the position, for which Ada Chan was nominated, with an individual
9 who is a City resident and who has the specific experience, skills, and
10 qualifications, but has been unable to do so at this time. The Rules Committee has
11 certified that Ada Chan is qualified to serve on the SOMA Community Stabilization
12 Fund Community Advisory Committee.
- 13 4. After exercising due diligence, the Board of Supervisors concludes that there is no
14 other possible representative, who is a resident of San Francisco and who has the
15 specific experience, skills, or qualifications possessed by this applicant, and who is
16 willing to serve on the SOMA Community Stabilization Fund Community Advisory
17 Committee at this time; and, be it

18 FURTHER MOVED, That the Board of Supervisors waives the residency requirement
19 for Ada Chan, as allowed in cases where no qualified City resident, willing to serve, can be
20 found, pursuant to Section 4.101 of the City Charter that requires person(s) appointed to
21 boards, commissions, and advisory bodies established by legislative act of the Board of
22 Supervisors to be resident(s) of the City and County of San Francisco.
