19 voters for the June 7, 2011, Consolidated Special Election, who are authorized by this motion

20 to prepare and submit arguments, may authorize or assign to any other person(s) under the

21 provisions of the San Francisco Elections Code Sections 530 and 550 (c) and (d) the right to

22 prepare and submit the proponent or opponent's ballot arguments and/or respective rebuttal
