14 the Board may determine to initiate the cost of living adjustment prior to executing the option;

16 WHEREAS, Should the Board determine not to exercise this two year option, the Clerk  
17 of the Board will notify the consultant by August 1, 2011, that the contract will end December  
18 31, 2011; now, therefore, be it

19 MOVED, That the Board of Supervisors of the City and County of San Francisco  
20 hereby amends its Agreement with A Joint Venture to extend the term of the agreement from  
21 January 1, 2012, through December 31, 2013; and, be it

22 FURTHER MOVED, That the Clerk of the Board of Supervisors is hereby authorized  
23 and directed to take all administrative steps necessary to carry out the intent of this Motion.
