15 Broker; Attorney; or a Property Appraiser accredited by a nationally recognized professional  
16 organization, or a Property Appraiser certified by the Office of Real Estate Appraisers; or as a  
17 current member of the Assessment Appeals Board, for a three-year term ending September 1,  
18 2014.

19           Richard Lee, seat 7 (ALTERNATE /HEARING OFFICER), succeeding himself, term  
20 expired, must meet the eligibility criteria set forth in Section 1624.05 of the California Revenue  
21 and Taxation Code. Must have a minimum of five years professional experience in the State  
22 of California as one of the following: Certified Public Accountant (CPA) or Public Accountant  
23 (PA); licensed Real Estate Broker; Attorney; or a Property Appraiser accredited by a nationally  
24 recognized professional organization, or a Property Appraiser certified by the Office of Real
