11 consistent with the objectives and policies of the General Plan and the Eight Priority Policies
12 of Section 101.1 of the Planning Code. Copies of said letters are on file with the Clerk of the
13 Board in File No. 111206 and is incorporated herein by reference; and, be it,

14 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own
15 and incorporates by reference herein as though fully set forth the findings made by the San
16 Francisco Redevelopment Agency, by its letter dated April 1, 2009 that the proposed
17 subdivision is consistent with the Mission Bay South Redevelopment Plan and Plan
18 Documents (as such term is defined therein). A copy of said letter is on file with the Clerk of
19 the Board in File No. 111206 and is incorporated herein by reference; and, be it,


20 FURTHER MOVED, That the certain map entitled "Final Map No. 5165, being a

24 Francisco, California", comprising 7 sheets, approved October 6, 2011 by Department of
25 Public Works Order No. 179,606 together with the Public Improvement Agreement dated

1 November 9, 2011 by and between FOCIL-MB, LLC and the City and County of San
2 Francisco ("City") are hereby approved and said map is adopted as an official Final Map of
3 Mission Bay for Assessor's Block 8727 Lot 5. A copy of said Public Improvement Agreement
4 is on file with the Clerk of the Board in File No. 111206 and is incorporated herein by
5 reference; and, be it,

6 FURTHER MOVED, That the San Francisco Board of Supervisors hereby authorizes
7 the Director of the Department of Public Works to enter all necessary recording information on
8 the Final Map and authorizes the Clerk of the Board of Supervisors to execute the Clerks
9 statement as set forth herein; and, be it,

10 FURTHER MOVED, That approval of this map is also conditioned upon compliance by
11 subdivider with all applicable provisions of the Mission Bay Subdivision Code and
12 amendments thereto.


