7 hereby appoint the hereinafter designated persons to serve as members of the Assessment  
8 Appeals Board No. 1, pursuant to the provisions of the Revenue and Taxation Code, Section  
9 1623, and the San Francisco Administrative Code, Sections 2B.1 through 2B.11, for the terms  
10 specified:

11 Joseph Tham, seat 2, succeeding Alec Lambie, term expired, must meet the eligibility  
12 criteria set forth in Section 1624.05 of the California Revenue and Taxation Code. Must have  
13 a minimum of five years professional experience in the State of California as one of the  
14 following: Certified Public Accountant (CPA) or Public Accountant (PA); licensed Real Estate  
15 Broker; Attorney; or a Property Appraiser accredited by a nationally recognized professional  
16 organization, or a Property Appraiser certified by the Office of Real Estate Appraisers; or as a  
17 current member of the Assessment Appeals Board, for the unexpired portion of a three-year  
18 term ending September 7, 2015.

19 Mark Watts, seat 5, succeeding Lawrence Lee, term expired, must meet the eligibility  
20 criteria set forth in Section 1624.05 of the California Revenue and Taxation Code. Must have  
21 a minimum of five years professional experience in the State of California as one of the  
22 following: Certified Public Accountant (CPA) or Public Accountant (PA); licensed Real Estate  
23 Broker; Attorney; or a Property Appraiser accredited by a nationally recognized professional  
24 organization, or a Property Appraiser certified by the Office of Real Estate Appraisers; or as a

2 term ending September 7, 2015.

3 Scott Spertzel, seat 6, (ALTERNATE /HEARING OFFICER), succeeding Mark Watts,  
4 term expired, must meet the eligibility criteria set forth in Section 1624.05 of the California  
5 Revenue and Taxation Code. Must have a minimum of five years professional experience in  
6 the State of California as one of the following: Certified Public Accountant (CPA) or Public  
7 Accountant (PA); licensed Real Estate Broker; Attorney; or a Property Appraiser accredited by  
8 a nationally recognized professional organization, or a Property Appraiser certified by the  
9 Office of Real Estate Appraisers; or as a current member of the Assessment Appeals Board,  
10 for a three-year term ending September 7, 2015.

11 Donna Crowder, seat 8, (ALTERNATE /HEARING OFFICER), succeeding Scott  
12 Spertzel, term expired, must meet the eligibility criteria set forth in Section 1624.05 of the  
13 California Revenue and Taxation Code. Must have a minimum of five years professional  
14 experience in the State of California as one of the following: Certified Public Accountant (CPA)  
15 or Public Accountant (PA); licensed Real Estate Broker; Attorney; or a Property Appraiser  
16 accredited by a nationally recognized professional organization, or a Property Appraiser  
17 certified by the Office of Real Estate Appraisers; or as a current member of the Assessment  
18 Appeals Board, for a three-year term ending September 7, 2015.


