3 **Motion appointing Leo O'Farrell, Linda Lau, Maria LeClair, Paula Jones, Jessie Mandle,**  
4 **and Mei Ling Hui, for indefinite terms, to the Food Security Task Force, residency**  
5 **requirements waived.**

7       MOVED, That the Board of Supervisors of the City and County of San Francisco does  
8 hereby appoint the hereinafter designated persons to serve as members of the Food Security  
9 Task Force, pursuant to the provisions of the San Francisco Health Code, Sections 470.1 and  
10 470.2, for the terms specified:

11       Leo O'Farrell, seat 8 (residency requirement waived), succeeding himself, term  
12 expired, must be from the Department of Human Services of the Human Services Agency, for  
13 an indefinite term.

14       Linda Lau, seat 9, succeeding herself, term expired, must be from the Department of  
15 Aging and Adult Services of the Human Services Agency, for an indefinite term.

16       Maria LeClair, seat 10 (residency requirement waived), succeeding herself, term  
17 expired, must be from the Department of Public Health, Nutrition Services, for an indefinite  
18 term.

19       Paula Jones, seat 11 (residency requirement waived), succeeding herself, term  
20 expired, must be from the Department of Public Health, Office of Food Systems, for an  
21 indefinite term.

22       Jessie Mandle, seat 12 (residency requirement waived), succeeding Maximilian Rocha,  
23 term expired, must be from the Department of Children, Youth and their Families, for an  
24 indefinite term.

2 Environment, Urban Agriculture program, for an indefinite term; and, be it

3 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 4 1. The membership of the Food Security Task Force has a goal to be representative of  
5 the diversity of the City and County of San Francisco.
- 6 2. Applicants Leo O'Farrell, Maria LeClair, Paula Jones, and Jessie Mandle,  
7 appointees, who are not residents of San Francisco, are persons with experience  
8 that uniquely qualifies them to serve on the Food Security Task Force.
- 9 3. The Food Security Task Force has attempted to fill the positions, for which  
10 Leo O'Farrell, Maria LeClair, Paula Jones, and Jessie Mandle were nominated, with  
11 individuals who are City residents and who have the specific experience, skills, and  
12 qualifications, but have been unable to do so at this time. The Rules Committee  
13 has certified that Leo O'Farrell, Maria LeClair, Paula Jones, and Jessie Mandle are  
14 qualified to serve on the Food Security Task Force.
- 15 4. After exercising due diligence, the Board of Supervisors concludes that there are no  
16 other possible representatives who are residents of San Francisco, who have the  
17 specific experience, skills, or qualifications possessed by these applicants, and who  
18 are willing to serve on the Food Security Task Force at this time; and, be it

19 FURTHER MOVED, That the Board of Supervisors waives the residency requirements  
20 for Leo O'Farrell, Maria LeClair, Paula Jones, and Jessie Mandle, as allowed in cases where  
21 no qualified City residents willing to serve can be found, pursuant to Section 4.101 of the City  
22 Charter that requires person(s) appointed to boards, commissions, and advisory bodies  
23 established by legislative act of the Board of Supervisors to be resident(s) of the City and  
24 County of San Francisco.


