

1 [Concurring in the Revised Declaration of Local Emergency - Rim Fire (Stanislaus National  
2 Forest Area)]

3 **Motion concurring in the September 19, 2013, Revised Declaration of Local Emergency**  
4 **by the Mayor and in the actions taken to meet the emergency.**

6 WHEREAS, On September 3, 2013, the Board of Supervisors concurred with the  
7 Declaration of Local Emergency received by Acting Mayor Mark E. Farrell, on August 22,  
8 2013, pursuant to Motion No. M13-109, on file with the Clerk of the Board of Supervisors in  
9 File No. 130809, which is hereby declared to be a part of this Motion as if set forth fully herein;  
10 and

11 WHEREAS, On September 19, 2013, Mayor Edwin M. Lee reaffirmed, revised, and  
12 declared a local emergency to exist in the connection with the wild fire (Rim Fire) that began  
13 on August 17, 2013, in the Stanislaus National Forest area located in Tuolumne County, 3  
14 miles northeast of Groveland and this fire has already impacted City assets and has potential  
15 to cause additional damage to property and equipment of San Francisco Public Utilities  
16 Commission and Recreation and Park Department resources; and

17 WHEREAS, The Mayor does hereby find that the aforesaid conditions of extreme peril  
18 justify and require a proclamation of the existence of a local emergency; and

19 WHEREAS, The Mayor has transmitted a copy of that Revised Declaration of Local  
20 Emergency to the Board of Supervisors, and such copy is located in File No. 130900; and

21 WHEREAS, The Mayor has directed the head of each department and agency to  
22 observe his or her proper relationship in the command structure of the Incident Command  
23 System (ICS), and be responsive to the orders and requests of the Lead Department  
24 designated to exercise supervision over his or her department during the course of this  
25 emergency; and

1           WHEREAS, The Governor of the State of California is hereby requested to include the  
2 area of the City and County of San Francisco in any emergency declaration by the State, and  
3 is further requested to ensure that the City and County of San Francisco is included in any  
4 emergency declaration that may be issued by the President of the United States; and

5           WHEREAS, The City and County of San Francisco also requests the State of California  
6 make available recovery assistance under the terms of the California Disaster Assistance Act  
7 and expedite access to federal resources and any other appropriate federal disaster relief  
8 programs; and

9           WHEREAS, This revised Declaration of Local Emergency shall be deemed to continue  
10 until it is terminated by the Mayor or the Board of Supervisors; all departments of the City and  
11 County of San Francisco are strictly enjoined to cooperate with the requests for material and  
12 personnel resources by the ICS staff of said City and County which is located in the  
13 Emergency Operations Center of the City and County of San Francisco; now, therefore, be it

14           MOVED, That the Board of Supervisors concurs with the Revised Declaration of Local  
15 Emergency issued by the Mayor, and in the actions taken by the Mayor to meet the  
16 emergency.
