9 WHEREAS, In Motion No. 19096, the Planning Commission found the subject
10 Tentative Map in compliance with the California Environmental Quality Act (California Public
11 Resources Code Sections 21000 et seq.) and found it consistent with the City's General Plan,
12 and the eight priority policy findings of Planning Code, Section 101.1. Said determination is
13 on file with the Clerk of the Board of Supervisors in File No. 141248 and is incorporated herein
14 by reference; and,

15 WHEREAS, Public Works, in a decision dated November 20, 2014, approved a
16 Tentative Map for a Six Residential and One Commercial Unit Mixed-Use New Construction
17 Condominium Project located at 3032, 3038-3040 Clement Street, Assessor's Block No.
18 1402, Lot Nos. 022 and 023. Said determination is on file with the Clerk of the Board of
19 Supervisors in File No. 141248 and is incorporated herein by reference; and,

20 WHEREAS, On December 1, 2014, Karl Nakamura, filed a timely appeal to the
21 decision of Public Works; and,

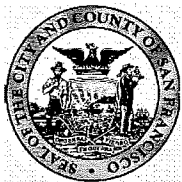
22 WHEREAS, On December 16, 2014, this Board held a duly noticed public hearing to


